Advocates for Homeless Families empowers motivated individuals to overcome homelessness. Families achieve success through a two year structured program of education, housing, and support services. Two programs are offered: Transitional Housing - provides housing for homeless families who must enroll in Advocates' program which will educate the participant on proper budgeting techniques and assist the family in seeking and maintaining employment and obtaining job skill training and/or additional educational training such as GED's or college degrees to seek better employment opportunities; Families Forward - is a similar program which supports families not yet homeless, but at risk for becoming homeless. Participants must adhere to Advocates' program guidelines or risk being terminated from the program.
