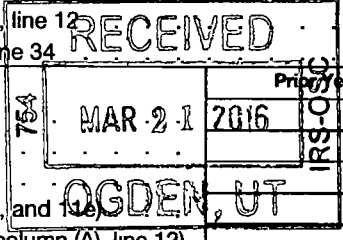

To proclaim locally through various types of outreach the message that Jesus is coming soon and it is time to get serious about our relationship with Him.

We lease antenna space on a commercial tower at 460 ft AGL and operate under a FCC Class C3 permit broadcasting ERP at 12.5 kw. This is a full-power Christian FM radio station which offers music, religious, health, and educational programs, through which we are proclaiming God is the answer for life's problems. In 2015 we began broadcasting in Spanish two hours each week day, including religious and character building programs. Beginning after Thanksgiving, 2015, until after New Years, 2016, we sponsored a 20 second video several times every hour on a digital billboard in Times Square, NYC, advertising our radio web site. During this time we experienced an additional 900+ discrete hits on our website. We also co-sponsor an annual week-end campmeeting where well-known radio speakers and local listeners can meet together for worship and seminars to learn how to prepare spiritually and physically for the soon coming of Jesus.
