Improving Concrete Durability Durability challenges, particularly with respect to quantifying freeze-thaw, salt scaling and alkalisilica reaction (ASR), remain prevalent in the concrete industry In an effort to further advance concrete durability, researchers at Oregon State University (OSU) and the University of New Brunswick(UNB) will utilize the groundbreaking modeling that has taken place at the Concrete Sustainability Hub (CSHub) at the Massachusetts Institute of Technology (MIT) The projects will examine new inputs and elements of ASR (UNB),salt scaling and freeze-thaw (OSU) and will include deliverables aimed at a better understanding of and the ability to control for durability challenges Additionally, the experience and relationshipsof the researchers at OSU and UNB with other organizations will assist in the expansion of this knowledge/increased implementation as well as the potential for increased collaborative funding of future research
