The Maryland Forestry Foundation's mission is to act as the fiduciary agent and fundraising manager for specific projects of the Maryland Association of Forest Conservancy District Boards. In it's role of support for the 24 local forestry boards, our Foundation provides important tax deductibility to corporate and private donors interested in the stewardship, conservation and sustainable use of Maryland's forest resources. We also administer statewide initiatives using state grant agreements.

These are vendor payments for the Healthy Forests / Healthy Waters Initiative as part of a Maryland Dept. of Natural Resources Grant Agreement. The Fdn contracts with natural resource consultants and with county Forestry Bds, in conjunction with MD Forest Service Staff, to implement tree planting projects on private land for the purposes of delivering quantifiable nutrient and sediment reductions thru Forestry Best Mgt Practices. The Fdn engages the local Forestry Bds by providing training and tech assistance that allows them to document the projects' implementations and to monitor their success. Vendors receiving payments:

These expenses are the lodging, meal and supplies costs incurred in the running of the Natural Resources Careers Camp, a one-week co-ed camp for high school students. NRCC offers mid-Atlantic students the opportunity to explore careers and college studies in the fields of forestry, wildlife, ecology, fisheries, watershed management and natural resources management. The camp is held at the Hickory Environmental Education Center in the mountains of Garrett County, MD where students learn to use GIS, GPS and other field tools related to careers in natural resources. Throughout the week, they work with industry professionals and gain valuable contact information. At College Night, they meet professors from the University of Maryland, Penn State, West Virginia University, Allegany College and Garrett College and hear about the type of majors that best suit their interests. Note, the other costs of the camp (stipends for college students who act as counselors, stipends for Camp Director and Night Counselors, advertising, website, etc.) total \$8,038. The revenue is from Tuition of \$450/students that is normally paid for by the local Forestry Boards and an Activity Fee of \$125 charged to the students.

4c (Code:) (Expenses \$ 21,303 including grants of \$ 21,303) (Revenue \$)
The Maryland Dept. of Natural Resources funds several grant programs through our Foundation :
1. \$10,278 - to fund the Maryland Urban and Community Forest Committee program (MUCFC) where a group of volunteer professionals and citizens promote the planting and care of trees by administering grants to community groups and schools. The max grant award is \$1,500. This year, we distributed \$10,278 to 12 groups.
2. \$10,825 - to fund the Mel Noland Challenge Grant which is intended to spur activity within the local county Forestry Boards. The boards are encouraged to develop projects at the local level that engage landowners, the community and students for the purposes of private forest stewardship. Max grant is \$2,500. We review applications and, if approved, distribute funds to the Bds and apply to DNR for reimbursement. We disbursed 6 grants in 2015.
3. \$200 - Fdn helps support the Project Learning Tree, a series of workshops in environmental education for teachers.
