

The NFPF is the nonprofit created by Congress to save America's film heritage. Working with archives, the NFPF preserves American films, improves access for education and exhibition, and encourages film as art, history, and cultural resource.

Preserving American films through grants. Saved 64 films through cash grants to 35 archives, historical societies, libraries, museums, and universities. Among the films slated for preservation were The Way of Peace (1947), an animated plea for pacifism by Frank Tashlin; Twice as Nice (1989), Jessie Maple's independent feature about basketball playing twin sisters; student works by animator Frank Mouris; and home movies of President Herbert Hoover, the 1944 Republican National Convention, and the Santa Fe Fiesta. The grants are open to American nonprofit and public organizations of all sizes and experience levels. Projects are selected by expert panels. Films preserved through NFPF grants are made available for education and shared with the public via screenings, exhibits, DVDs, broadcasts, and the web. The NFPF website showcases select examples from the program.

Repatriating American films unavailable in the U.S. The NFPF continued working on the partnership announced in 2014 with the EYE Filmmuseum Netherlands to preserve and make available more than 50 American films that have been unseen for decades. The films include the animated educational film Fifty Million Years Ago (1925), an introduction to the theory of evolution; Flaming Canyons (1929), a stencil-colored travelogue promoting the wonders of National Parks; The Last Word in Chickens (1924), surveying modern egg production and poultry raising techniques; and Mickey's Circus (1927), featuring Mickey Rooney, in his first starring role.

In addition, the NFPF is commissioning music and scholarly essays for the online presentation of fiction films from the EYE Project.

Promoting film preservation through publications. The NFPF produces the award-winning Treasures DVD series presenting American films preserved by archives and previously unavailable on video. The sets are used in libraries and universities around the world. In 2015 the NFPF pressed ahead with Treasures 6: Next Wave Avant-Garde, surveying experimental filmmakers who rose to prominence after 1965. In addition, we continued to distribute our Film Preservation Guide (2004), which can be downloaded free or mailed on request. The award-winning primer has been translated into 3 languages. Our Field Guide to Sponsored Films (2006) is also distributed through these channels.

Each year all Board members review the NFPF's conflict of interest policy and sign a statement disclosing any dealings that might harbor or appear to harbor a potential conflict of interest with another nonprofit or business entity with which they are affiliated. Should a conflict appear to exist, any contract or agreement relating to that business arrangement must be signed by a Director not affiliated with any of the related parties.

As per the NFPF's founding federal legislation, Directors receive no compensation but may be reimbursed for "necessary travel" (such as travel to attend annual meetings). The legislation also sets the compensation ceiling for NFPF employees at the level of a GS-15 in the federal service. (In practice, all NFPF salaries are lower.) The NFPF's overall employee salary and benefit package is approved by the Board of Directors as part of the NFPF's annual budgeting process. Any change in the compensation level of individual employees requires the written approval of two members of the NFPF Executive Committee.
