The Organization funded the operation and maintenance of a hospital in the Nuba mountains to include supplying medicines and medical supplies, staff salaries, and staff training. The Organization funded United States and foreign organizations to provide services to the people of South Sudan.

During 2015, the Sudan Relief Fund sent funds for emergency humanitarian aid to help alleviate the suffering of the more than two million refugees from the civil war that erupted on December 15, 2013.
