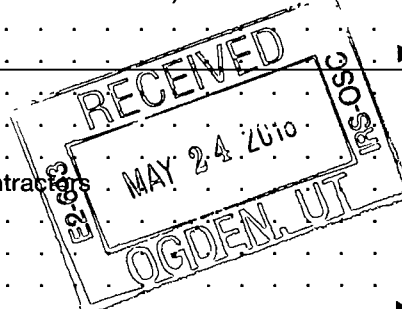

In 2015 the Petty Cash Fund was used for 2 programs, playing cards, Netflix for movies, food and serving supplies for the annual Art Show Reception for Center artists, holiday gifts for the senior volunteers at the Front Desk and in the kitchen, a gift card for an instructor, cash to the Front Desk for making change, etc. The Council keeps a record and replenishes the fund as needed.

Part V. All assets are contained in the bank checking account. The Council owns no property and has no liabilities. All assets are designated for support of the Ellicott City 50+ Center.
