CARDIAC SAFETY TECHNICAL COMMITTEE THE MISSION OF THE CARDIAC SAFETY TECHNICAL COMMITTEE IS TO IMPROVE PUBLIC HEALTH BY REDUCING UNANTICIPATED CARDIOVASCULAR-RELATED ADVERSE EFFECTS FROM DRUGS OR CHEMICALS AND DEVELOP INNOVATIVE APPROACHES TO SUPPORT EARLY DETECTION AND PREDICTION AS WELL AS IMPROVED UNDERSTANDING OF CARDIOVASCULAR TOXICOLOGY AND PATHOBIOLOGY. IN 2015, THE COMMITTEE CONTINUED TO SPONSOR PROJECTS ADDRESSING CARDIOVASCULAR SAFETY TESTING AS WELL AS A STRATEGIC COMMITTEE MEETING HELD IN ALEXANDRIA, VA. THE COMMITTEE ALSO PARTICIPATED AND PRESENTED THEIR WORK IN MEETINGS IN THE US, CZECH REPUBLIC AND JAPAN. KEY PROJECTS INCLUDED A RETROSPECTIVE ANALYSIS OF NONCLINICAL AND CLINICAL DATA FROM A LITERATURE REVIEW AND JOINT HESI-FDA DATABASE TO BETTER UNDERSTAND AND CHARACTERIZE ASSAY CONCORDANCE. ADDITIONALLY, 3 EXPERIMENTAL STUDIES WERE FINALIZED AND SUBSEQUENT DATA ANALYSES COMPLETED, INCLUDING A MULTI-SITE, CROSS COMPARISON OF CONTRACTILITY MEASURES IN CANINES, A MULTI-SITE PILOT STUDY EXPLORING VARIABILITY IN NOVEL CARDIOMYOCYTE STEM CELL ASSAYS, AND A PROOF-OF-CONCEPT STUDY EXPLORING BIOMARKERS OF HEMOSTASIS AND THROMBOSIS. THE LITERATURE REVIEW AND CONTRACTILITY STUDIES BOTH RESULTED IN PUBLICATIONS AND THE COMMITTEE IS WORKING ON ANOTHER 5 PUBLICATIONS DETAILING THE EXPERIMENTAL WORK AND HESI-FDA DATABASE.

DEVELOPMENTAL AND REPRODUCTIVE TOXICOLOGY (DART) TECHNICAL COMMITTEE THE MISSION OF THE DART COMMITTEE IS TO PROVIDE A FORUM WHERE SCIENTISTS FROM INDUSTRY, GOVERNMENT AND ACADEMIA CAN EXCHANGE INFORMATION AND INITIATE ACTIVITIES TO ADVANCE SCIENCE RELATED TO DEVELOPMENTAL AND REPRODUCTIVE TOXICOLOGY, AND TO DEVELOP CONSENSUS IN THE SCIENTIFIC COMMUNITY ON THE APPROPRIATE USE OF EXPERIMENTAL TOXICITY DATA FOR HUMAN HEALTH RISK ASSESSMENT. IN 2015, THE COMMITTEE CONTINUED TO SPONSOR SEVERAL PROJECTS ADDRESSING DEVELOPMENTAL AND REPRODUCTIVE TOXICITY. KEY PROJECTS INCLUDED COMPLETING AN ANALYSIS OF A DATABASE OF HISTORICAL AND CURRENT PHARMACEUTICAL DART STUDIES TO ADDRESS THE CURRENT RE-EVALUATION OF THE PHARMACEUTICAL TESTING PARADIGM. THE COMMITTEE ALSO CONTINUED ITS SUPPORT OF TWO EXPERIMENTAL PROJECTS: A MULTI-LABORATORY EVALUATION OF A CONSENSUS LIST OF DEVELOPMENTAL TOXICANTS FOR THE IN VITRO METHODS, AND AN EVALUATION OF THE DEVELOPMENT AND EXPRESSION OF KEY PLACENTAL TRANSFER RECEPTORS IN SEVERAL PRECLINICAL SPECIES. THE COMMITTEE ALSO HELD TWO WORKSHOPS IN THE WASHINGTON, DC AREA AND ANOTHER WORKSHOP IN AMSTERDAM, NETHERLANDS. ADDITIONALLY, THE COMMITTEE CONTINUED ITS EFFORTS ON TWO LARGE REVIEW PAPERS ON DEVELOPMENTAL IMMUNOTOXICOLOGY AND THE ROLE OF CHEMICALS AS OBESOGENS. FINALLY, THE COMMITTEE LAUNCHED A LARGE MULTI-PRONGED PROJECT TOWARDS ADDRESSING NEONATAL DISEASE. THE COMMITTEE ALSO SPONSORED/PRESENTED THE OUTPUT OF THE PROJECTS DESCRIBED AT SCIENTIFIC MEETINGS IN THE US AND EUROPE.

PROTEIN ALLERGENICITY TECHNICAL COMMITTEE (PATC) AN IMPORTANT COMPONENT OF THE SAFETY ASSESSMENT OF BIOTECHNOLOGY PRODUCTS IS TO MAKE A DETERMINATION OF THE ALLERGENIC POTENTIAL OF NEWLY EXPRESSED PROTEINS. THE PATC REPRESENTS THE ONLY HESI COMMITTEE THAT IS DEVOTED EXCLUSIVELY TO SCIENCE ISSUES ASSOCIATED WITH AGRICULTURAL BIOTECHNOLOGY AND FOOD SAFETY. ITS MISSION IS TO ADVANCE THE SCIENTIFIC UNDERSTANDING OF RELEVANT PARAMETERS FOR CHARACTERIZING THE ALLERGENIC POTENTIAL OF NOVEL PROTEINS AND BIOTECHNOLOGY PRODUCTS. IN 2015, THE PATC CONTINUED ONGOING RESEARCH ON A MULTI-SECTOR LABORATORY RESEARCH PROJECT AIMING AT THE DEVELOPMENT OF NEW DIGESTIBILITY MODEL (5) FOR INVESTIGATING ALLERGENICITY OF PROTEINS. PRELIMINARY RESULTS HAVE BEEN ASSEMBLED IN A SUMMARY REPORT THAT WAS MADE AVAILABLE TO THE EUROPEAN FOOD SAFETY AUTHORITY PILOT FOCUS GROUP ON ALLERGENICITY. THE COMMITTEE INITIATED AND SPONSORED TWO NEW PROJECTS: (1) NEW RESEARCH IN A JOINT EFFORT WITH THE UNIVERSITY OF TEXAS MEDICAL BRANCH (GALVESTON, TEXAS) AND THE FOUNDATION FOR APPLIED MOLECULAR EVOLUTION (GAINESVILLE, FLORIDA) TO DEVELOP INFORMATICS METHODS FOR IDENTIFICATION AND CLASSIFICATION OF PROTEIN TOXINS, (2) A LARGE SCALE COLLABORATIVE PUBLIC-PRIVATE EFFORT, IN PARTNERSHIP WITH THE JOINT INSTITUTE FOR FOOD SAFETY AND NUTRITION AT THE UNIVERSITY OF MARYLAND (HTTP://JIFSAN.UMD.EDU), FOR THE DEVELOPMENT OF A PUBLICLY ACCESSIBLE, TRANSPARENT, AND RELIABLE TOOL FOR ALLERGEN IDENTIFICATION AND COMPARATIVE ANALYSES, A RELEVANT TOOL FOR FOOD ALLERGY SAFETY ASSESSMENT (THE COMPARE DATABASE, COMPREHENSIVE PROTEIN ALLERGEN RESOURCE). THE PATC PUBLISHED THE OUTCOME OF THEIR WORK FROM SEVERAL PROGRAMS IN THREE MANUSCRIPTS IN THE PEER-REVIEWED LITERATURE AND INITIATED THE PLANNING OF A PUBLIC WORKSHOP TO BE HELD IN 2016. THE PATC STRIVES TO ESTABLISH METHODS USEFUL IN A WEIGHT-OF-EVIDENCE APPROACH TO THE EVALUATION OF NOVEL PROTEINS EXPRESSED IN BIOTECHNOLOGY PRODUCTS, PROMOTE UNDERSTANDING ABOUT WHAT MAKES A PROTEIN ALLERGENIC, AND COMMUNICATE ITS FINDINGS TO THE ACADEMIC, REGULATORY, AND INDUSTRIAL COMMUNITIES.

THE COMPENSATION COMMITTEE DETERMINES APPROPRIATE, ANNUALLY, AND WHENEVER A MODIFICATION IN COMPENSATION IS PROPOSED, THE REVIEW INCLUDES AN EVALUATION OF THE PERFORMANCE OF THE EMPLOYEES AND AN ANALYSIS OF APPROPRIATE COMPARABILITY DATA. BASED ON ITS REVIEW, THE COMPENSATION COMMITTEE SHALL DECIDE JUST AND REASONABLE COMPENSATION AMOUNTS FOR THE EMPLOYEES. THE COMPENSATION COMMITTEE RECORDS ITS DECISION IN CONTEMPORANEOUS WRITTEN MINUTES IN ACCORDANCE WITH THE IRS SAFE HARBOR REGULATION WITH REGARD TO EXCESS BENEFITS. THE COMPENSATION COMMITTEE IS ONLY REQUIRED TO PERFORM THE COMPENSATION REVIEW DESCRIBED ABOVE WITH REGARD TO COMPENSATION OF THE EXECUTIVE DIRECTOR.
