**AMENDED AND RESTATED
ARTICLES OF INCORPORATION OF
THE NACS FOUNDATION**

- FIRST:** The name of the corporation is The NACS Foundation (hereinafter the "Corporation").
- SECOND:** The period of duration is perpetual.
- THIRD:** The Corporation is organized exclusively for charitable, scientific, literary or educational purposes within the meaning of Section 170(c)(2) of the Internal Revenue Code of 1986, as amended. The Corporation is organized, and at all times thereafter is operated, exclusively for the benefit of and to carry out the charitable and educational purposes of National Association of Convenience Stores, an organization described in Section 501(c)(6) of the Internal Revenue Code of 1986, as amended, which would be an organization described in Section 509(a)(2) of the Internal Revenue Code of 1986, as amended, if it were an organization described in Section 501(c)(3) of the Internal Revenue Code of 1986, as amended.
- More specifically, but within such general purpose, the Corporation is organized:
- (1) To create, operate, and maintain a library and research facility, open to the public, relating to issues of safety, efficiency, convenience, and human relations within the convenience store industry; and
- (2) To conduct seminars and perform other educational training relating to the convenience store industry.
- FOURTH:** The sole member of the Corporation shall be National Association of Convenience Stores.
- FIFTH:** The Corporation shall issue no capital stock.
- SIXTH:** The directors of the Corporation (denominated as trustees) shall be elected or appointed by National Association of Convenience Stores in accordance with the Bylaws of the Corporation (the "Bylaws"). Any vacancy occurring on the Board of Trustees of the Corporation (the "Board of Trustees") may be filled by action of: (a) National Association of Convenience Stores, or (b) a majority of the entire Board of Trustees then in office.
- SEVENTH:** Provisions for the regulation of the internal affairs of the Corporation, except as provided in these Articles, shall be determined and fixed by the Bylaws as adopted by the Board of Trustees. If the Bylaws so provide the Board of Trustees may, by resolution or resolutions passed by a majority of the whole Board of Trustees, designate two (2) or more of the trustees to serve as a committee, which,

to the extent provided in such resolution or resolutions and to the extent consistent with law, shall have and may exercise the powers of the Board of Trustees in the management of the business and affairs of the Corporation, and may have power to authorize the seal of the Corporation to be affixed to all papers which may require it.

At all times, and notwithstanding merger, consolidation, reorganization, termination, dissolution or winding up of the Corporation, voluntarily or involuntarily, or by operation of law or any other provision hereof:

(1) The Corporation shall neither have nor exercise any power, nor shall it directly or indirectly engage in any activity, that would (a) prevent it from obtaining an exemption from Federal income taxation as a corporation described in Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or (b) cause it to lose such exempt status.

(2) The Corporation shall not be operated for the purpose of carrying on a trade or business for profit.

(3) No part of the income of the Corporation shall inure to the benefit of any trustee, director or officer of the Corporation or any private individual, except that reasonable compensation may be paid for services rendered on behalf of the Corporation, and no trustee, director or officer of the Corporation, or any private individual shall be entitled to share in any distribution of any of the assets of the Corporation upon its dissolution.

(4) No substantial part of the activities of the Corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, except as may otherwise be permitted in accordance with an election pursuant to Section 501(h) of the Internal Revenue Code of 1986, as amended; nor shall it in any manner or to any extent participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office; nor shall the Corporation engage in any activities that are unlawful under applicable Federal, state or local laws.

(5) If for any period the Corporation is a private foundation as defined by Section 509 of the Internal Revenue Code of 1986, as amended, or corresponding provisions of any subsequent Federal tax laws, then during such period the Corporation shall be subject to the following restrictions and prohibitions:

(a) The Corporation shall distribute its income for each taxable year at such time and in such manner as not to become subject to the tax on undistributed income imposed by Section 4942 of the

Internal Revenue Code of 1986, as amended, or corresponding provisions of any subsequent Federal tax laws.

(b) The Corporation shall not engage in any act of self-dealing as defined in Section 4941(d) of the Internal Revenue Code of 1986, as amended, or corresponding provisions of any subsequent Federal tax laws.

(c) The Corporation shall not retain any excess business holdings as defined in Section 4943(c) of the Internal Revenue Code of 1986, as amended, or corresponding provisions of any subsequent Federal tax laws.

(d) The Corporation shall not make any investments in such manner as to subject it to tax under Section 4944 of the Internal Revenue Code of 1986, as amended, or corresponding provisions of any subsequent Federal tax laws.

(e) The Corporation shall not make any taxable expenditures as defined in Section 4945(d) of the Internal Revenue Code of 1986, as amended, or corresponding provisions of any subsequent Federal tax laws.

(6) Upon the dissolution of the Corporation, the Board of Trustees shall, after paying or making provision for the payment of all of the liabilities and obligations of the Corporation, distribute all assets of the Corporation exclusively to such organization or organizations organized and operated exclusively for charitable, educational, or scientific purposes, as shall at such time qualify as an exempt organization or organizations under Sections 501(c)(1) or 501(c)(3) of the Internal Revenue Code of 1986, as amended, or corresponding provisions of any subsequent Federal tax laws, as the Board of Trustees shall determine, pursuant to a plan of distribution.

EIGHTH: The Corporation's initial registered office address, which is the business address of the initial registered agent, is:

NINTH: The name of the Corporation's initial registered agent, whose business office is identical with the above-registered office, is:

The initial registered agent is a domestic corporation authorized to transact business in the Commonwealth of Virginia.

TENTH: The personal liability of the trustees of the Corporation is hereby eliminated to the fullest extent permitted by the laws of the Commonwealth of Virginia, and the Corporation shall, to the fullest extent permitted by the laws of the Commonwealth of Virginia, indemnify all persons whom it may indemnify pursuant thereto.

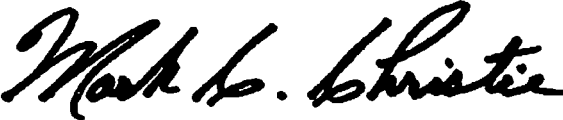
