ORGANIZATIONAL SUPPORT TO MARIE STOPES INTERNATIONAL FOR EXPANDING DELIVERY OF GLOBAL FAMILY PLANNING SERVICES In 2015, Mane Stopes International (MSI) completed its 2010-2015 five year strategy, "Power of 10" Over the last five years, MSI doubled its health impact across our global network in 37 countries, providing increased access to contraception, particularly in the areas of long-acting and permanent methods of contraception In 2015, MSI reached more people than ever before It is estimated an excess of 21 million people globally were using a method of contraception supplied by MSI and MSI continues to reach clients in locations where the need for reproductive health services is urgent, An estimated 27% of MSI's clients in 2015 were living in extreme poverty, 27% being young people under the age of 25

MSI SUPPORT - EXPANDING DELIVERY OF GLOBAL FAMILY PLANNING SERVICES IN AFRICA In 2015 MSI expanded its impact in Africa, particularly in the Sahel, a region with high unmet need for contraception MSI deployed 26 outreach teams, operated 9 centers, and engaged more than 200 franchisees and employed 240 staff members in the region MSI continued to expand its newest service delivery channel in Africa, MS Ladies, which empowers midwives and nurses as entrepreneurs to deliver quality family planning services in their communities Access to services continued to expand through the training of public and private providers MSI also advocated for policy changes so that family planning services can be provided by a wider variety of trained service providers Through 4 3 million client visits, MSI reached millions of women in need in the region with family planning care
