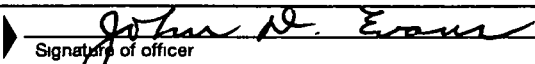

Part I Line 10 Grants and similar amounts paid \$45,413

All of our grants support projects and similar activities in the Dominican Republic. However, with only one exception, all grants are actually made to the US-based Peace Corps Partnership Program. Thus, when the funds actually arrive at the Peace Corps office in the Dominican Republic, they are considered Peace Corps funds. All of our grants are recommended by Peace Corps Volunteers who work with community leaders to jointly develop the proposals and implement the projects. In 2015, as indicated in Part II, we funded 17 community infrastructure projects, such as fuel efficient stoves, latrines, cement floors, potable water, community libraries, etc. The last project, in the amount of \$2000, did not pass through the Peace Corps Partnership Program. It represented start-up funds for a pilot project providing university level scholarships to three Dominican youths who have been working with Peace Corps Volunteers as leaders of programs for young people. The money was transferred to a member of our organization who resides in the Dominican Republic who subsequently paid the tuition, books and travel expenses of the three pilot participants.

Part I Line 16 Other expenses paid \$920

These expenses represent fees paid (primarily to Pay Pal), the cost of web-hosting and domain name maintenance, the annual fee to the Commonwealth of Virginia to maintain our corporate status, the fee to maintain our affiliation with the National Peace Corps Association, accounting software update fees, and a wire transfer fee.

Part I Line 20 Other changes in net assets or fund balances -\$8203

This information comes directly from our quarterly and annual statements issued by our investment firms. We earned \$16,235 in Dividends in 2015, but suffered a negative change in asset value of \$24,438, resulting in a net loss of \$8203.
