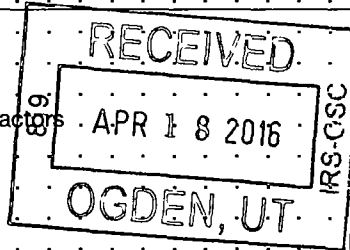



SurvivorVision (SV) is organized and operated to attract public support on an ongoing basis. The organization maintains bona fide programs for obtaining funds from the public, including the solicitation of donations through its web site, networking, mailings, various public fundraising events, Paypal and Amazon.com. In addition, the organization distributes periodic communications, maintains a presence on Facebook, and participates in a number of public events for charitable causes.

SurvivorVision is a nine year old organization with a small staff that is constantly looking for ways to generate additional public funds. SV continues to solicit new public donors and increase awareness of the organization and its mission, and its fundraising efforts are reasonable in light of its charitable activities. Each year SV supports pediatric cancer oncology survivors and fighters, as well as their families, through a diverse spectrum of organizations who maintain or support programs and services that seek to improve their lives. All funds raised by the organization are used to satisfy its mission. The organization pays no salaries, and had investment income of only \$77 in 2015, which was less than 1% of total revenue.

SV's public support percentage for years 2015, 2014 and 2013 was 100%. While SV's five year public support is 25.4% of its income, it should be noted that for several years the organization was the beneficiary of one generous donor. Excluding those donations, SV's public charity percentage is 100%. In addition, SV maintains a very low level of administrative expenses, which are incurred in an effort to generate additional public donations.

SV's governing body is made up of people with diverse personal and professional backgrounds and experiences, including financial professionals, educators, salespersons and healthcare industry professionals. Furthermore, the organization's founder herself is a pediatric cancer survivor who created the organization's vision and mission from first hand experience. SV assists, directly and indirectly, many children and families each year through a number of programs and grants distributed throughout the nation. SV's primary program is its textbook scholarship program, which encourages pediatric cancer survivors to take responsibility for their education, as they move forward with trying to live a normal life.
