Working Bikes acquires donated or discarded bicycles and gives those bicycles new homes. The organization donates bicycles internationally, fixes bicycles to donate and sell locally, and educates the public in bicycle repair, safety and reuse, while supporting healthy cycling.

In 2015, Working Bikes collected over 9,000 used bicycles with the help of individuals, businesses and community organizations. Working Bikes held 70 bike collection events, often in conjunction with municipally supported recycling fairs, and provided information on safe-riding, basic bike repair, and recycling at dozens of community events. 74 individuals and entities-- including 38 bike shops, 25 property companies and 11 police departments--were donation drop off" partners for unwanted bicycles to be repurposed by Working Bikes. Hundreds of volunteers, including over 200 new to Working Bikes in 2015, facilitated the donation of 13 shipping containers full of used bicycles to our international partners in Africa and Central America. Volunteers and staff also repaired and donated 851 bicycles to low-income individuals in and around Chicago, including children, veterans, refugees, job-seekers, and clients of social service organizations through its local donation program. WB was a vital resource to its Southwest Chicago community throughout 2015. At four weekly volunteer sessions, volunteers served their community while building community with others in the space. CPS students fulfilled required community service hours, justice-involved individuals served court hours, and drop-in volunteers donated their time, learned bicycle mechanics, and shared meals together.
