THESE FUNDS ENABLE THE HOSPITAL TO OFFER STATE-OF-THE-ART CARE TO ITS PATIENTS WHILE UNDERWRITING ITS EFFORTS TO PROVIDE HEALTH SERVICES TO THE ECONOMICALLY DISADVANTAGED.
