Part V, Line 2(1): CADCO Foundation granted \$89,712 to Capital Area Development Corporation of West Virginia for support of its business incubator building.

Part V, Line 2(2): Enterprise Properties granted \$110,000 to CADCO Foundation for economic and community development programs

Part V, Line 2(3): Capital Area Development Corporation of West Virginia owed two separate notes payable to CADCO Foundation. These funds were borrowed from the Foundation's board-designated endowment for the purpose of improvement to the business incubator building owned and operated by CADCO of WV. Funds were repaid monthly and semi-annually to the Foundation's endowment account, based on amortization schedules computed with competitive fixed rates of interest. At 12/31/15, total notes payable to CADCO Foundation were \$238,568. Total payments to CADCO Foundation on these notes payable in 2015 were \$43,435 including interest of \$7,725. In a separate transaction, CADCO of WV received in 2013 a \$45,000 loan from CADCO Foundation as seed funding for a Building Maintenance Fund. A \$35,000 payment on the loan was made in 2014, with the remaining \$10,000 balance repaid in 2015.

Part V, Line 2(4): CADCO Foundation pays nominal membership dues of \$365 annually to CADCO of WV. All administrative and managerial functions of CADCO Foundation are performed by CADCO staff without charge to CADCO Foundation.

Part V, Line 2(5): As with many related organizations managed by shared staff and utilizing shared resources, CADCO Foundation, and its affiliate, CADCO, use an intercompany due to/from account to capture transfers and other transactions during the normal course of recordkeeping. The net increase in the Foundation's payable to CADCO in 2015 was \$5,043.
