HISTORY OF THE ORGANIZATION

CommunityWorks in West Virginia, Inc. (CWWV) is a statewide membership organization made up
of 27 local agencies that provide housing-related services throughout the state of West
Virginia. CWWV was established in 1991 and is certified by the United States Department of
the Treasury as a Community Development Financial Institution (CDFI). CWWV has been
chartered member of NeighborWorks America since 1996. The mission of CWWV is to create
housing and community development solutions for all West Virginians through a network of
member organizations.

CWWV carries out its mission by providing effective training and technical assistance to
local housing organizations; developing sustainable capital investments in local housing;
advocating for sound housing policies; and increasing public awareness of local housing
issues throughout West Virginia.

CWWV has been the leader and driving force in the affordable housing industry in the state
for 25 years. The organization was instrumental in the adoption of legislation that not
only created the West Virginia Affordable Housing Trust Fund, but also legislation that

provided a dedicated source of revenue to resource the Trust Fund. CWWV also coordinates the West Virginia Housing Policy Group that conducted the necessary research and analysis to develop a comprehensive West Virginia Housing Policy Framework in September 2013. The Purpose of the Housing Policy Framework is establish broad goals and direction related to the state's housing policy, and to assist in coordination between state agencies, between state and local government, and between the private and public sector. The Housing Policy Framework helps ensure that policy responses to West Virgini's housing issues are not piecemeal, but instead link together to form a cohesive and comprehensive strategy. CWWV is also the lead host of the West Virginia Housing Conference.

REVOLVING LOAN FUNDS

CWWV Home Ownership Revolving Loan Fund capitalized with funds received from NeighborWorks America since 1996. These funds are made available to the member organizations to provide their clients with homeowner opportunities, and existing home owner with renovations to address health and safety code violations. Since 2006 CWWV has invested \$3,142,000 creating 74 new homeowners, and provided \$204,682 in rehab loans to 17 existing homeowners.

PROGRAMS SUPPORT ITS MISSION

Nonprofit Capacity Building Initiative

CommunityWorks in West Virginia has launched the NonProfit Capacity Building Initiative.

Despite all the training and technical assistance efforts by CWWV, West Virginia nonprofits in the housing field continue to "leave money on the table" because they do not have the capacity to apply for and manage funds, develop and complete projects, navigate the complex and ever-changing housing rules and regulations and develop organizational sustainanbility strategies. Because housing affordability and housing quality are significant challenges for nearly one-fifth of West Virginia households, strong and visible housing orgnaizations are needed to meet the unique challenges of the State.

This issue has been identified and examined by the West Virginia Housing Policy Work Group (a group of experienced colleagues representing federal, state, and local stakeholders within the housing industry). While developing the West Virginia Housing Policy Framework, the group researched and analyzed issues unique to the State, informed by a survey of 206 individuals in the housing field. Nearly all of the housing stakeholders who completed the survey indentified the need for technical assistance. The factors most frequently selected as inhibiting housing development were related to the lack of planning at the local level and a lack of recognition of the importance of housing as component of economic and

community development. A series of recommendations were made, including expanding funding sources for the preservation and rehabilitation of existing housing stock; increasing access to capital and technical assistance to nonprofit housing organizations; and establishing a technical assistance program to provide consulting services in the areas of compliance, community development and financing, contract management, and marketing plan development.

To address these recommendations, CWWV developed the Noprofit Capacity Building Initiative (NCBI) so that member organizations will have the skills and expertise to successfully develop housing opportunities and support community development efforts throughout West Virginia. The goal of the NCBI is to build the capacity of State housing organizations for full utilization all federal and state funding available. The NCBI will provide the following specialized project development and technical assistance to 10 targeted Nonprofit Member Organizations to achieve immediate high impact: Volunteer Program

CommunityWorks in West Virginia, a statewide intermediary of nonprofit organizations provided support for local, volunteer-based housing organizations in their efforts to assist low income and elderly homeowners with needed repairs and rehabilitation of their homes during the past year. Assistance is provided to local organizations in the form of relatively small grants for needed construction materials, tools, transportation of volunteers to work sites, or other tangible items necessary to support the volunteer labor available to these local programs. Available funds are distributed to local volunteer organizations through small grants to purchase materials, supplies and other items needed in order to take full advantage of volunteer help in rehabilitating housing. CWWV provided volunteer-based programs with financial assistance during 2014-2015 resulting in the rehabilitation of an estimated 224 housing units and 7 new homes constructed located in number of different counties in West Virginia. number of different counties in West Virginia. Owner occupied rehabilitation assisted through these volunteer-based programs are those below 30% of the AMI and are often elderly or handicapped resident in need of assistance. The assistance provided is roof replacements, installation of porches and handicap ramps.

Housing Policy Group

In September 2012, a group of dedicated individuals representing a wide range of housing related entities came together to discuss the rising housing challenges in West Virginia combined with declining federal support for all housing assistance. The group discussed the feasibility of developing a comprehensive housing policy for West Virginia in hopes of more fully engaging the state government in improving housing outcomes for West Virginia house holds. The group agreed the timing and opportunity for public policy change around housing was critical, and development of a policy would provide a framework to (1) address issues and promote coordination and efficiency within the housing industry, and (2) engage the Governor and other policy makers to promote progressive policy actions.

CommunityWorks in West Virginia agreed to coordinate the effort, and secured a grant from the Claude Worthington Benedum Foundation for the necessary support, research, and analysis to develop the policy framework with the group. Using a neutral facilitated process, the group expanded their work group to include federal, state, local, and private stakeholders in the housing industry, and began meeting in February of 2013 on a bi-monthly basis to develop the components of the housing policy framework. Additional activities of the group included research of other housing policy efforts and best practices in other states, analysis of national and West Virginia housing market data, development of guiding principles, identification of critical issues, and consensus on goals and recommendations to move West Virginia forward.

The Housing Policy Group outlined specific strategies to undertake in 2015 to move the housing policy framework forward (1)Continue to convene, support, and facilitate and expanded, diverse policy work group and ongoing structure to carry out policy priority recommendations. (2)Increase resources and develop specific strategies for housing development, preservation, and rehabilitation to meet housing demands. (3)Promote statewide planning coordination and integration of housing with other state improvement efforts. (4)Elevate the importance of progressive housing policy among policy makers and key stakeholders.

In 2015 a collaboration of organizations including CommunityWorks in West Virginia, Inc. the lead organization, Habitat for Humanity of West Virginia, West Virginia Community Action Partnership; West Virginia Coalition to End Homelessness, West Virginia Partnership for Elder Living, West Virginia Affordable Housing Trust Fund, West Virginia Housing Development Fund planned and hosted the 2nd Annual West Virginia Housing Conference 2015 held September 2014, at the Embassy Suites in Charleston, West Virginia. The purpose of the conference was to:

- Assess the changing landscape of housing in WV, collectively understand our current housing needs across the state, and share new ideas to meet the housing demands;
- Provide training and networking opportunities for housing providers across traditional agency and service-organization lines;
- Explore restructuring our approaches to housing development to make the best use of limited resources;
- Plan for the affordable housing needs of all West Virginia families, including but not limited to, the elderly, persons with disabilities, veterans, and transitional and homeless populations.
