The mission of the North Carolina Holocaust Foundation is fivefold: (1) to educate North Carolinians on the historical importance of the Holocaust, (2) to educate North Carolinians on the lessons learned from the Holocaust, (3) to remember and commemorate those individuals who perished due to planned and systematic Nazi persecution, (4) to remember and honor the liberators in the Holocaust and (5) to reflect upon genocidal events happening around the world today and to call for action.

The Teacher Workshops consist of North Carolina public school teachers meeting with (1) a university professor to learn about European anti-Semitism and the events leading to the 1932 election of the Nazi Party in Germany, (2) a retired public school teacher to learn how to teach the Holocaust to middle school and high school students, and (3) a Holocaust survivor to hear a first-hand account of his/her suffering and surviving the Holocaust. The overall themes of the Teacher Workshops are (1) to explain why the teaching of the Holocaust is relevant and important and (2) to provide teachers with the skills and methods to teach students how to understand the lives and circumstances of others, and how to empathize and appreciate, rather than fear, differences among people.

The \$14,221.64 include (1) hotel, honorarium, travel (gas mileage reimbursement), and food expenses for the speakers and (2) the copy expense for teacher handouts. The NC Holocaust Foundation conducted a total of seven (7) teacher workshops in the spring & fall semesters of 2015 (locations were: Kinston, Raleigh, Landis, Jamestown, Rocky Point, Winston-Salem and Asheville). Travel expenses for workshop participants totaled \$1,286.63 and will be reflected Part IX, Line #17; see also Schedule O, pages 1 and 3.

4b (Code: COMMEM) (Expenses \$ 4,921.08 including grants of \$) (Revenue \$)

The Commemoration line item comprises two Holocaust observances that took place in 2015. The State Holocaust Commemoration occurred on March 29, 2015, at Meredith College in Raleigh. The keynote speaker was Dr. Zev Harel, a Holocaust survivor currently living in Greensboro. There was a panel discussion before the formal service where three other Holocaust survivors spoke about their Holocaust experiences and their lives after the Holocaust. A second observance that was sponsored by the NC Holocaust Foundation occurred on April 29, 2015, at the North Carolina General Assembly/State Legislature in Raleigh. A joint resolution was approved by the North Carolina House of Representatives and the North Carolina Senate (House Joint Resolution #668) that honored and recognized the United States Armed Forces on the 70th anniversary of liberating the Dachau concentration camp.

The \$4,921.08 include honorarium and travel for participants, the printing of programs, security, catered food for two receptions, and photography. Travel expenses for participants for both observances totaled \$275.52 and will be reflected Part IX, Line #17; see also Schedule O, pages 1 and 3.

4c (Code: THEATRE) (Expenses \$ 4,380.00 including grants of \$) (Revenue \$)

The Touring Theatre of North Carolina performs the Holocaust play, "Let Your Children Tell." The play, which lasts approximately 90 minutes and has a cast of five players, depicts the actual lives of four middle school-aged children who suffered in the Holocaust. Some of the children survived the Holocaust while others were murdered. The play is shown at middle schools and high schools in North Carolina. In 2015, the play was shown at North Lenoir High School in LaGrange, NC (350 students in attendance), Kinston High School in Kinston, NC (300 student in attendance), and Yadkin Valley Regional Academy in Lexington, NC (150 students in attendance).

The expenses include gas mileage, hotel and food per diem, and an honorarium for each actor. The NC Holocaust Foundation does not break-out the \$4,380.00, expenses are paid by the NC Holocaust Foundation to the Touring Theatre of North Carolina in a lump sum.
