**In 2015, with help from 165 volunteers, services were provided to support 598 client visits. 335 pregnancy tests were performed and 213 ultrasounds. Early detection of pregnancy in this largely rural population is critical to guiding pregnant women to early prenatal care for both the health of the mother and the baby. As planning began for 2015, the Board of Directors made the decision to launch an Education initiative in 2015 aimed at reducing unplanned pregnancy and the spread of STDs. We will also be pursuing a new program to assist those facing a devastating diagnosis during pregnancy. Fundraising for these programs began in November.**
