The Community Foundation Real Estate Management Fund, on behalf of The Community Foundation of Greater Greensboro, is planning, designing and constructing a new public park in downtown Greensboro. A tentative opening of the park - which is seen as the centerpiece of a new "cultural campus" downtown - has been set for August 2016. The Park is made possible through a generous donor's bequest to be used "for the creation of a public park for the benefit and enjoyment of the general population of Greensboro, particularly children and their families." The Carolyn and Maurice LeBauer City Park will provide exceptional recreational equipment and activities, educational opportunities and public art, all within an extremely attractive, well-landscaped setting. The bequest directs The Community Foundation to carry out and ensure the intent of LeBauer's wishes, and upon completion to transfer the park to the city of Greensboro. In accordance with generally accepted accounting principles, the majority of costs related to the design, development and construction of the park are capitalized and reflected on the Balance Sheet.
