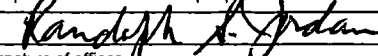
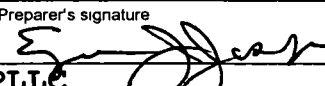

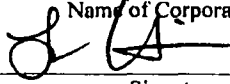

2. Amend the third sentence of Article Seven (Members) of the Articles of Incorporation to read as follows: "The initial members of the corporation shall be ABCCM Doctors' Medical Clinic, Inc., Davidson Medical Ministries Clinic, Community Clinic of High Point, Community Care Clinic of Rowan County, The Open Door Clinic of Raleigh, and The Care Clinic of Fayetteville."
3. Amend Article Nine (Principal Office) of the Articles of Incorporation to delete all of the text and to replace it with the following: "The mailing address of the principal office of the corporation shall be: 1399 Ashleybrook Lane, Suite 110, Winston-Salem, North Carolina 27103."
4. Amend Article Thirteen (Amendments) of the Articles of Incorporation by deleting all of the text and replacing it with the following: "Unless other required by the North Carolina Nonprofit Corporation Act (the "Act"), in order for an amendment to the corporation's Articles of Incorporation to be adopted, the amendment shall be approved: (1) by the Board of Directors or in lieu thereof in writing by the number or proportion of voting members entitled under the Act to call a special meeting to consider such amendment; and (2) by the members entitled to vote thereon by two-thirds of the votes cast or a majority of the votes entitled to be cast on the amendment, whichever is less."
