The Community Foundation of NC East, Inc. was originally founded as The Greater Greenville Community Foundation, Inc. in 1999. The organization changed its name in 2016 to better represent its widening outreach of services to all of eastern North Carolina.

Federal Disaster Area Relief

The Community Foundation of NC East, Inc. is located in Pitt County, North Carolina.

This location was severely affected by Hurricane Matthew in the fall of 2016, and President Obama declared Pitt County to be a covered federal disaster area. With this designation, the residents and tax entities of Pitt County automatically became eligible for tax relief and an extension of tax filing deadlines. Accordingly, this return was prepared and submitted past the November 15, 2016 deadline.
