We work in partnership with local organizations, international institutions and individuals on environmental and human rights related issues.

Crude Accountability manages a program called, Prove They Are Alive!, which works to find out the fates of individuals who have been disappeared in Turkmenistan's prisons. We work with families of the disappeared to find out information about their relatives, and compile and gather that information into directories. We also work on the international level to raise awareness about this issue and to try to find out what has happened to these individuals so that it does not happen again.

Crude Accountability works together with our partner, Environmental Watch on the North Caucasus, a Russian environmental nongovernmental organization, to organize exchanges for environmental experts in the United States and Russia. We bring U.S. environmental experts to Russia's Kuban region to work with EWNC and other environmental experts on wetlands protection. We also bring our Russian colleagues to the United States, most recently to North Carolina, to learn about wetlands protection and shoreline conservation in an effort to create new protected territories on the shoreline of Russia's Sea of Azov.

Crude Accountability is working with environmental organizations in Kazakhstan and on the international level to relocate the village of Berezovka, which is located dangerously close to the Karachaganak oil and gas condensate field in Western Kazakhstan. We work on environmental education issues, environmental health issues and general awareness raising in the community.
