Kenyan Women's Network Our women's cooperative program is our largest program focusing on the social and economic empowerment of women living in extreme poverty in Kenya. Major accomplishments in 2015 include partnering with two new cooperatives made up of 50 women. Six months of education and life-skills training were conducted on topics including human rights, basic business skills, leadership, bookkeeping, personal development and basic health and nutrition. After the six months of education, they joined our 16 other cooperatives in small business growth activities to help increase income levels of these women and their families. The program grew to a total of just over 500 women and includes follow-up trainings for all of the women in First Aid, monthly monitoring and resources for small business growth.

4b (Code:) (Expenses \$ 123,740 including grants of \$ 62,458) (Revenue \$)

Youth Leadership Network: Student Sponsorships Program in Kenya worked with 35 students through 2015. The kids range in age seven to twenty and would have no other way of paying for their school fees but have shown great promise and dedication to school. The goal of the program is to see the students through their senior year of high school and we have now had several reach that goal and are continuing on in college / university. Some of these kids are in boarding school to provide proper shelter, a safer place to live and learn. This program is also providing shelter for several of the students and medical costs as they arise. The program also has a yearly retreat, one for the boys and one for the girls, to provide a sense of family and belonging as well as a safe place to share, gain life-skills and grow.

This program allows kids the opportunity to reach their full potential and improve communities through access to education

Youth Leadership Network: Young Women's Leadership Challenge (YWLC) - U.S. - Houston Area

This program provides an opportunity for high school aged young women to learn about themselves, develop leadership skills and understand their role in improving not only their own lives but the lives of others. We hosted a 6-day camp in 2015 with a total of 23 young women from across Houston. We discussed in detail the following topics: Global issues / human rights, self-esteem and body image, financial literacy, leadership, conflict resolution and peacebuilding. A host of speakers came daily from different careers and backgrounds to share their stories and knowledge related to career paths and personal goal setting. We also emphasize service and our service project was putting together care packages of books and educational materials for our students in Kenya. This camp was hosted at Rice University.

All program activities conducted at the local level in Kenya are monitored and reviewed by local Pangea staff, an outside accountant as well as by The Pangea Network HQ staff and Board. Monthly requisitions for funding are received from the Kenya office, reviewed and wired to cover that month's program and administrative expenses. A monthly review is conducted by the independent accountant in the region, reviewing receipts and expenses and sends an expenditure report, along with bank statements that are then reviewed by the Pangea head office. Also, as newly required by Kenya law, we have audited books for all Kenya accounts starting in 2015.

Program local staff do monthly monitoring of all women's cooperatives and review financial statements and also do random site visits of their small businesses.

Pangea HQ staff visit the field office on an annual basis for site visits with staff to the women's cooperatives and student sponsorship students to ensure program impact and efficiency and review all policies and procedures, conduct performance reviews, etc.

Program investments in Kenya are \$51,615. These revolving funds are given to the cooperatives and distributed as revolving source of funds for the women to start and grow small businesses and increase income levels.
