



Part III Organization's Primary Exempt Purpose: The Belt Volunteer Ambulance is a Public Charity formed to provide no-cost or low-cost pre-hospital emergency care and emergency ambulance transportation for residents of Belt and Eastern Cascade County, Montana.

Part III, 2015 Achievements: During 2015, BVAS provided medical care to 115 patients in our service area and the surrounding area. All services were provided by volunteers who received no compensation for their services. Through grants, BVAS was able to obtain a 12 lead cardiac monitor that transmits ECGs to ER for rapid diagnosis and treatment of cardiac issues. Extensive training was provided to EMTs for use of this equipment. A Lucas II Chest Compression device was also acquired and training provided. Acquisition of this new equipment and increased abilities of EMTs will result in better patient outcomes for those residing in or traveling through BVAS service area.
