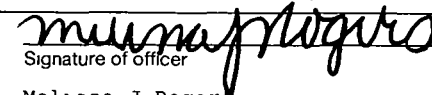

The Sisters of Charity Foundation of South Carolina (Foundation) is a faith-based organization, deeply rooted in the principles of the gospel and the traditions of the Catholic Church. As a ministry of the Sisters of Charity Health System, the Foundation is committed to addressing the cause and effects of poverty in South Carolina. The Foundation is dedicated to efforts which help build a sustainable, healthy economy, promote educational success, support stronger families and contribute to long-term community development.

4b (Code:) (Expenses \$ 167,791 including grants of \$ 5,000) (Revenue \$)

The Foundation is one of the few organizations that provide support for the health, education, and social service ministries of Catholic women religious. In addition to grant specific ministries, the Foundation supports efforts of women religious to collaborate, improve, and expand their services for the vulnerable and underserved. The Foundation also supports research into the role of women religious in ministry, and how to continue their work, as the number of sisters in active ministry continues to decline.

4c (Code:) (Expenses \$ 346,066 including grants of \$ 1,200) (Revenue \$)

The Foundation has invested significantly in programs that support low income fathers over the past eighteen years. Additionally, the Foundation has started other initiatives that have an effect on marginalized populations. The Foundation is currently working on an Immigrant Families initiative which works to support individuals who have migrated to South Carolina but suffer many challenges including access to health care, legal issues, work issues, community service issues, and systems support. The Foundation started a Kinship Care program in 2014 and will continue this program in the years to come. This initiative is designed to support more than fifty thousand children across the state that are being raised by a family member other than a parent. These families have significant issues that other families do not have. The Foundation is working with the Annie C. Casey Foundation and the Duke Endowment to support funding, policy analysis, and ways that the State Social Service System can better serve these caregivers and the children they are raising.

The Sisters of Charity Foundation of South Carolina begins its' grant award process by reviewing grant proposals to ensure that the Foundation guidelines are met for mission, geographic area, program area, and population served. Required documents from potential grantees include audited financial statements, IRS determination letter and IRS Form 990. After initial verification has taken place, a program officer/grants manager is assigned to each proposal. Additionally, site visits are conducted with representatives from the organization, and a narrative summary is completed for the distribution/grant committee. All proposals are then carefully reviewed by staff and the distribution/grant committee to identify those applications that best serve the Foundation's mission, and analyze proposed budgets to fulfill our obligation as stewards of the Foundation funds. After the selection process is complete, the distribution committee makes its' recommendations to the full Board of Trustees at its' next meeting. Once a grant has been awarded, grants are monitored through site visits to ensure proper use of funds. Periodic reports and budgetary information are required and reviewed for consistency and adherence to the program goals and objectives. When the grant period has ended, closed grant/final evaluation reports are completed and reviewed by program officers/grants manager for compliance with the grant agreement and used as an internal document for future funding. Grant files are archived electronically for future reference.
