SINCE 2013, STAFF PROVIDED FREE, LOCAL, UNBIASED ENROLLMENT ASSISTANCE TO SOUTH CAROLINA RESIDENTS TO HELP THEM UNDERSTAND THEIR OPTIONS FOR HEALTH INSURANCE COVERAGE IN BOTH THE FEDERALLY FACILITATED HEALTH INSURANCE MARKETPLACE (HEALTHCARE.GOV) AND SC HEALTHY CONNECTIONS MEDICAID. THIS WORK IS CONDUCTED WITH PARTNERS INCLUDING ABLE SC, APPLESEED LEGAL JUSTICE CENTER, RICHLAND LIBRARY, SC HIV/AIDS COUNCIL, SC PASOS, SC SMALL BUSINESS CHAMBER OF COMMERCE, AND DECO RECOVERY MANAGEMENT.
