MANY OF THE RESIDENTS WORK AT THE STORE DURING THEIR STAY AT THE MISSION WHICH PROVIDES DIGNITY AND SELF-WORTH TO THE RESIDENTS OF THE MISSION. THE MISSION MART PROVIDES FREE CLOTHES AND OTHER NEEDS TO THE NEEDIEST. THE NEEDS INCLUDE BUT ARE NOT LIMITED TO TRAINING AND SERVICE OPPORTUNITY AND REVENUE TO FUND THE VITAL PROGRAMS OF THE MISSION AS THE DONATIONS TO THE MISSION MART ARRIVE, THE RESIDENTS LEARN CUSTOMER SERVICE AND RETAIL RELATED SKILLS WHILE RECEIVING AND SORTING CONTRIBUTIONS. SALES FROM THE MISSION MART HELPS BRING IN ADDITIONAL AND ESSENTIAL SUPPORT FOR KEY PROGRAMS (MEALS, LODGING, HOT SHOWERS, ETC.)
