The Association provides ongoing support for the following affiliate groups: SC Business Licensing Officials Association, SC Utility Billing Association, SC Community Development Association, Municipal Finance Officers, Clerks and Treasurers Association, Municipal Human Resources Association, SC Municipal Attorneys Association, SC Association of Stormwater Managers, Municipal Technology Association of SC, SC Association of Municipal Power Systems, Municipal Court Administration Association of SC and the Association of SC Mayors. RISK MANAGEMENT AND INSURANCE SERVICES: The Association manages four insurance programs including two self-funded insurance programs, an insurance agency and an OPEB trust. Services provided include: workers compensation insurance, property and liability insurance, placement of ancillary policies and an Other Retiree Benefits Trust. These products are provided within separate related companies (see Schedule R) with the management of the programs provided by the Association. In addition, the Association's Risk Management Services (RMS) staff helps program members build effective safety programs to lower their insurance costs through reduction of claims. RMS also assists members through written programs/standards, audits and inspections, technical assistance, training sessions, online training courses, safety grants, a newsletter and other resources. Further information on the individual programs is provided in Schedule O.

ADVOCACY: Cities and towns work together to advocate the role of strong cities as a critical part of the state's competitiveness. Part III Line 1: The Municipal Association of South Carolina is temporarily allocated 100% of the GAAP profits of Gervais Street Associates until all losses previously absorbed by the Association have been recouped. When this is completed, proportionate allocation of profits will resume with distribution based on capital investment percentages for all three partners.

Part V Line 1(j): Related entities South Carolina Municipal Insurance Trust, South Carolina Insurance and Risk Financing Fund and South Carolina Other Retirement Benefits Employer Trust pay rent to the Municipal Association. Rent is allocated based on square footage occupied and is included in the administrative fee paid to the Association.

Part V Line 1(k): The Municipal Association leases facilities from Gervais Street Associates.

Part V Line 1(l): The Association performs services for all entities listed in Schedule R Part II. The risk management entities (listed on lines 1 through 3 of Part II) reimburse the Association for direct staffing costs as well as support services through payment of administrative fees. The SC Association of Municipal Power Systems pays an administrative fee for support services but is not allocated rent or staffing costs. The SC Downtown Development Association is currently inactive and does not pay an administrative fee to the Association.
