Pt VI, Line 12c EACH BOARD MEMBER IS REQUIRED TO SIGN THE ORGANIZATION'S CONFLICT OF  
INTEREST POLICY ON AN ANNUAL BASIS. PURSUANT TO THIS POLICY EACH OFFICER  
AND BOARD MEMBER WILL RECUSE THEMSELVES FROM ANY DISCUSSION AND VOTE FOR  
WHICH A CONFLICT FOR THEMSELVES OR THEIR FAMILY EXISTS. DETERMINATIONS  
OF WHETHER A CONFLICT EXISTS ARE MADE AT A MANAGEMENT, BOARD MEMBER,  
OFFICER, AND INDIVIDUAL LEVEL. ACTUAL CONFLICTS ARE REVIEWED BY THE  
BOARD, WITHOUT THE PRESENCE OF THE INTERESTED PARTY.
