COUNSELING: CENTER POINT COUNSELING PROVIDES SLIDING-SCALE COUNSELING SERVICES FOR INDIVIDUALS, COUPLES AND FAMILIES. IN 2015, 1,577 COUNSELING SESSIONS WERE CONDUCTED WITH 224 PATIENTS. WILHEIT SERVICES PROVIDES FREE THERAPEUTIC SERVICES FOR STUDENTS IN THE GAINESVILLE CITY AND HALL COUNTY SCHOOL SYSTEMS. THE DELIVERY OF SERVICES IS PROVIDED BY GRADUATE LEVEL INTERNS AND ASSOCIATE LICENSED THERAPISTS THAT ARE CLINICALLY SUPERVISED. 55 STUDENTS WERE SERVED FROM AUGUST 2014 THROUGH DECEMBER 2014. 178 STUDENTS WERE SERVED FROM JANUARY 2015 THROUGH MAY 2015.

MENTORING: OUR MENTOR PROGRAM RECRUITS AND TRAINS CARING ADULTS TO WORK ONE-ON-ONE WITH STUDENTS IN GAINESVILLE CITY, HALL COUNTY SCHOOLS AND BOYS AND GIRLS CLUBS. THESE MENTORS AGREE TO MEET WITH THEIR STUDENTS ONCE A WEEK FOR THE DURATION OF THE ACADEMIC YEAR AND FOCUS ON IMPROVING ACADEMICS, ATTENDANCE, BEHAVIOR, PEER RELATIONS, AND BONDING WITH SCHOOL. MENTORS RECEIVE A TWO-HOUR TRAINING SESSION AND A BACKGROUND CHECK. ONCE TRAINED, THE MENTOR CHOOSES THE SCHOOL OR CLUB IN WHICH THEY WOULD LIKE TO SERVE. PROGRAM EVALUATIONS ARE CONSISTENTLY POSITIVE AND DEMONSTRATE STUDENT IMPROVEMENT. OVER 300 STUDENTS WERE SERVED DURING 2015.
