Highlighted races include premier races such as the AJC Peachtree Road Race, Atlanta 10 Miler and Thanksgiving Day Half Marathon, as well as a Grand Prix Series, All Comers Track and Field, and Cross Country events. For 2015 our premier races engaged more than 90,000 runners combined, many of whom used the events as a goal to get in shape and live healthier lifestyles. All our races and events encourage runners, both our 24,000+ members and the public alike the chance to compete and enhance physical fitness.

Atlanta Track Club is dedicated to inspiring and engaging Atlanta area youth to make better lifestyle choices and become active through the sport of running. Founded in 2007, Kilometer Kids has impacted more than 10,000 young people in metro Atlanta and beyond.
