CURRENTLY, THE FOCUS IS ON PROMOTING THE OPTIMIZATION OF BRAIN DEVELOPMENT FROM CONCEPTION TO THREE YEARS OF AGE. THE INSTITUTE SEEKS TO ACHIEVE ITS GOALS BY FOCUSING INTERNALLY ON DATA GATHERING AND SYNTHESIS, TRANSLATION AND DISSEMINATION OF THESE DATA AND MEASUREMENT OF UPTAKE OF THIS INFORMATION. ULTIMATELY IT IS EXPECTED THAT THIS INFORMATION MAY INFLUENCE POLICY DEVELOPMENT SURROUNDING ISSUES RELATED TO YOUNG CHILDREN. EXTERNALLY, THE INSTITUTE SUPPORTS RESEARCH, EDUCATION, AND SELECTIVE PROGRAMMATIC INITIATIVES THAT ARE CONSISTENT WITH OUR STATED GOALS.

THE URBAN CHILD INSTITUTE IS COMMITTED TO IMPROVING THE HEALTH AND WELLBEING OF CHILDREN IN MEMPHIS, TN IN 2015, THE FOCUS WAS ON PROMOTING THE OPTIMIZATION OF BRAIN DEVELOPMENT WITH A PARTICULAR EMPHASIS ON SOCIAL/EMOTIONAL DEVELOPMENT FROM CONCEPTION TO THREE YEARS OF AGE THE URBAN CHILD INSTITUTE SOUGHT TO ACHIEVE ITS GOALS BY FOCUSING INTERNALLY ON DATA, AND DISSEMINATION EXTERNALLY, UCI SUPPORTED RESEARCH, EDUCATION, AND SELECTIVE PROGRAMMATIC INITIATIVES THAT WERE CONSISTENT WITH OUR STATED GOALS IN 2015, UCI PUBLISHED "OFF TO A GOOD START" WHICH PROVIDED A DEFINITION OF NORMAL SOCIAL AND EMOTIONAL DEVELOPMENT AND INCLUDED INFORMATION FOR PARENTS, CHILD CARE PROVIDERS, AND THE GENERAL COMMUNITY IN THE HOPE THAT THESE TIPS COULD CONTRIBUTE TO THE OPTIMAL DEVELOPMENT OF SOCIAL AND EMOTIONAL SKILLS THIS PUBLICATION REPLACED THE TRADITIONAL "DATA BOOK" THAT HAD BEEN PRODUCED FOR EACH OF THE PREVIOUS EIGHT YEARS UCI CONTINUED TO FULFILL ITS DISSEMINATION GOALS BY HOSTING A SERIES OF EDUCATIONAL MEETINGS REGARDING CHILDREN'S HEALTH, SOCIAL AND EMOTIONAL DEVELOPMENT THAT WERE OPEN TO THE PUBLIC SPEAKERS INCLUDED WIDELY RECOGNIZED LOCAL AND NATIONAL EXPERTS UCI STAFF PROVIDED MANY PRESENTATIONS AND LED GROUP DISCUSSIONS IN ADDITION UCI PROVIDED SPACE IN OUR OWN FACILITY FREE OF CHARGE FOR NOT FOR PROFIT ORGANIZATIONS WITH AN INTEREST IN CHILDREN'S ISSUES FOR THEIR OWN MEETINGS AND CONFERENCES UCI DEVELOPED A MULTIMEDIA PRESENTATION THAT RUNS CONTINUOUSLY IN OUR LOBBY ABOUT EARLY BRAIN DEVELOPMENT WE REQUEST THAT ALL GROUPS THAT USE OUR FACILITY MAKE AN EFFORT TO GO THROUGH THIS EXHIBIT IN THE HOPE THAT IT WILL BE ANOTHER WAY TO INCREASE THEIR SENSITIVITY TO THE IMPORTANCE OF EARLY BRAIN DEVELOPMENT IN 2015, MORE THAN 20,000 PERSONS USED THE FACILITY UCI STAFF SERVED AS PARTICIPANTS AND LEADERS IN A VARIETY OF CHILD RELATED COALITIONS THAT HAVE AS A GOAL BRINGING COMMUNITY GROUPS WITH SIMILAR INTERESTS TOGETHER IN ORDER THAT THEY MIGHT SHARE EXPERIENCES, GAIN INSIGHT INTO WHAT OTHERS ARE DOING AND POTENTIALLY DEVELOP COLLABORATIVE PROJECTS OTHER DISSEMINATION EFFORTS INCLUDED FORMAL PRESENTATIONS PROVIDED TO VARIOUS COMMUNITY GROUPS BY STAFF FROM UCI THE UCI STAFF ALSO HELPED COMMUNITY GROUPS WITH THE DEVELOPMENT OF THEIR OWN EARLY BRAIN AWARENESS MESSAGES THE BEST EXAMPLE OF THIS IS THE COLLABORATION WITH THE NEIGHBORHOOD CHRISTIAN CENTERS TWO TO FOUR TIMES A MONTH, BRIEFS RELATED TO EARLY CHILDHOOD ISSUES WERE POSTED ON OUR WEBSITE AND SENT TO APPROXIMATELY 5,000 RECIPIENTS IN THE REGION THESE WERE LITERATURE AND DATA BASED DESCRIPTIONS OF ISSUES RELATED TO EARLY CHILDHOOD EXPERIENCES IN MEMPHIS AND HOW LOCAL GROUPS AS WELL AS OTHER COMMUNITIES HAVE ADDRESSED SIMILAR ISSUES UCI CONTINUES TO SUPPORT NOT FOR PROFITS IN THE COMMUNITY THAT HAVE AS A FOCUS EARLY CHILDHOOD A CONTRIBUTION OF \$740,000 IN 2015 WENT TO SUPPORT A LONG TERM RESEARCH PROJECT THAT IS BEING CONDUCTED BY THE UNIVERSITY OF TENNESSEE'S DEPARTMENT OF PREVENTIVE MEDICINE CALLED THE CONDITIONS AFFECTING NEUROCOGNITIVE DEVELOPMENT AND LEARNING IN EARLY CHILDHOOD STUDY (CANDLE) THIS IS A PROSPECTIVE STUDY DESIGNED TO DETERMINE WHAT SPECIFIC FACTORS DURING THE FIRST THREE YEARS OF A CHILD'S LIFE CAN BE IDENTIFIED THAT INFLUENCE BRAIN DEVELOPMENT THE ULTIMATE OUTCOME FROM THIS STUDY MAY HAVE IMPORTANT NATIONAL IMPLICATIONS BY COMBINING INFORMATION FROM THE CLINICAL PART OF THIS STUDY, WITH GENOMIC INFORMATION FROM BIOLOGICAL SPECIMENS FROM THE MOTHERS AND CHILDREN THESE STUDIES ARE EXPECTED TO PROVE USEFUL IN UNDERSTANDING WHY SOME CHILDREN ARE BETTER PREPARED FOR SCHOOL, MORE LIKELY TO BE OBESE, HAVE ASTHMA, HAVE SOCIAL/EMOTIONAL ISSUES ETC TO THIS POINT, THE STUDY HAS BEEN SUCCESSFUL IN NOT ONLY ENROLLING SUBJECTS BUT ALSO IN RETAINING THE MEMBERS OF THE COHORT UCI MADE A MAJOR INVESTMENT WITH THE RAND CORPORATION TO WORK WITH THE CANDLE DATA TO ENSURE IT HAS BEEN "CLEANED", A TERM USED TO INDICATE THAT THE DATA HAS BEEN RIGOROUSLY CHECKED TO ENSURE THAT IT HAS BEEN COLLECTED AND CODED CORRECTLY AND CONSISTENTLY ADDITIONAL UCI FUNDING SUPPORTED THE DEVELOPMENT OF AN INFRASTRUCTURE FOR THE CANDLE PROJECT THAT TOOK ADVANTAGE OF THE GREAT NATIONAL INTEREST IN THIS PROJECT FINALLY, UCI PROVIDED MAJOR SUPPORT TO A COMMUNITY SERVICE ORGANIZATION CALLED NEIGHBORHOOD CHRISTIAN CENTERS (NCC) HISTORICALLY THIS GROUP FOCUSED ON THE BASIC HUMAN NEEDS OF THE CLIENTS THEY SERVE THAT ARE AMONG THE MOST DISADVANTAGED IN OUR COMMUNITY IN THIS EFFORT, NCC TOUCHED AS MANY AS 49,000 LIVES EACH YEAR SUPPORT OF THE NCC BY UCI HAS AS AN ULTIMATE GOAL THE STRENGTHENING OF PROGRAMS FOCUSED ON PREGNANT WOMEN AND THEIR YOUNG CHILDREN AND IN BRINGING THE MESSAGE OF THE IMPORTANCE OF THE FIRST THREE YEARS OF LIFE TO THESE AT RISK FAMILIES THE NCC STARTED A PROGRAM BASED UPON SUPPORT BY UCI CALLED OPERATION SMART CHILD AND USE A CURRICULUM DEVELOPED IN PARTNERSHIP WITH UCI STAFF CALLED "TOUCH TALK READ AND PLAY" OVER 200 PARENTS COMPLETED ALL 4 MODULES OF THE CURRICULUM IN 2015 A CORE ELEMENT OF THIS PROGRAM IS A UCI-DEVELOPED CONCEPT OF TEACHING PARENTS AND PROVIDERS ABOUT THE IMPORTANCE OF TOUCHING, TALKING, READING AND PLAYING WITH THEIR CHILDREN ALL OF THE ACTIVITIES ARE IMPORTANT FOR NORMAL CHILD DEVELOPMENT, ARE EASY TO DO AND COST VERY LITTLE AS PART OF THE CURRICULUM, INFORMATION ABOUT BRAIN DEVELOPMENT IS INCLUDED UCI WORKED WITH THE UNIVERSITY OF TENNESSEE HEALTH SCIENCE CENTER HOLDING REGULAR MEETINGS WITH PEDIATRIC RESIDENTS WHERE BRAIN DEVELOPMENT WAS DISCUSSED AND THE RESIDENTS WERE PROVIDED AN OPPORTUNITY TO ATTEND CLASSES AT THE NCC TO SEE HOW THIS MESSAGE WAS BEING DISSEMINATED TO PARENTS OF YOUNG CHILDREN UCI SUPPORTED A SMALL PILOT STUDY THROUGH THE PEOPLE FIRST PARTNERSHIP TO DETERMINE IF AN EVIDENCED BASED PROGRAM CALLED NURTURING PARENTS COULD HELP IMPROVE BOTH PRE-K TEACHING SKILLS AS WELL AS PARENTING SKILLS
