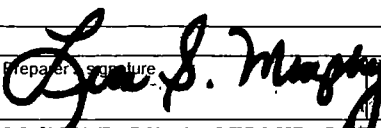

THE COMMUNITY FOUNDATION IS THE ONLY FUNDING SOURCE THAT REACHES ALL TYPES OF CHARITIES ACROSS THE OUTER BANKS, SUPPORTING PROGRAMS IN THE ARTS, EDUCATION, HEALTH AND HUMAN SERVICES, HISTORIC PRESERVATION, THE ENVIRONMENT, AND ANIMAL SERVICES.
