OPERATION OF A GENERAL ACUTE CARE AND SUB-ACUTE CARE HOSPITAL WITH 551 LICENSED BEDS, TOTAL (551 ACUTE AND 0 SUB-ACUTE) PATIENT DAYS FOR ADULTS AND PEDIATRICS FOR 2015 WERE 112,445, NEWBORN DAYS WERE 12,829 (FOR BOTH TERM & ICU NURSERY), AND OUTPATIENT VISITS WERE 498,119. EMERGENCY ROOM REGISTRATIONS WERE 79,938, OBSERVATION STAYS WERE 12,041, CARDIOVASCULAR INTERVENTIONAL PROCEDURES WERE 10,336 AND RADIOLOGY PROCEDURES WERE 224,398, OCCUPATIONAL MEDICINE VISITS WERE 23,096 AND HOME HEALTH VISITS FOR 2015 WERE 51,517. WITHIN ALL THESE INDICATORS ARE THE EFFORTS OF UNIVERSITY HEALTH SERVICES, INC TO SERVICE THE NEEDS OF THE COMMUNITY, WHICH INCLUDE THE INDIGENT. IN 2015 THE COST OF INDIGENT AND CHARITY CARE PROVIDED, WITH NO LOCAL FUNDING, WAS \$33,297,821. HOWEVER, THE HOSPITAL DID RECEIVE DISPROPORTIONATE SHARE (DSH) PAYMENTS TO HELP WITH THIS SERVICE OF \$3,783,254(NET) AND UPPER PAYMENT LIMITS (UPL) FUNDS OF \$1,459,463(NET). THE \$33,297,821 INCLUDES THE COST FOR PROVIDING INPATIENT AND OUTPATIENT SERVICES FOR INDIGENT AND CHARITY CARE PATIENTS OF \$21,362,001. ALSO \$1,529,367 TO HELP SUPPORT COMMUNITY BASED CLINICS, \$10,406,453 FOR UNCOMPENSATED PHYSICIAN SERVICES FOR INDIGENT AND CHARITY CARE PATIENTS. ALSO PROVIDED ARE PROGRAMS FOR CONGESTIVE HEART FAILURE AND ASTHMA/COPD, WHICH HELPED INDIGENT PATIENTS MANAGE THEIR CONDITION AND IMPROVE THE QUALITY OF THEIR LIVES. OTHER COMMUNITY OUTREACH SERVICES FOR 2015 INCLUDE DIABETES TESTING AND EDUCATION, PROSTATE SPECIFIC ANTIGEN (PSA) TESTING, SKIN CANCER SCREENINGS, FREE COUNSELING AND EDUCATION FOR WOMEN AND THEIR FAMILY MEMBERS THROUGH ALL THE STAGES OF BREAST CANCER, FREE MAMMOGRAMS, HEART HEALTH EDUCATION, AND SUPPORT GROUPS FOR CANCER, HEART ATTACK, AND STROKE. IN 2015 UNIVERSITY HOSPITAL REACHED MORE THAN 600,000 PEOPLE AND INVESTED MORE THAN \$236,173 IN FREE SCREENINGS, COMMUNITY EDUCATION, PUBLICATIONS, AND MORE. ADDITIONALLY, IN 2015 OVER \$331,344 WAS PROVIDED FOR HEALTH PROFESSIONAL EDUCATION FOR CARDIOVASCULAR AND RADIOLOGY SCHOOLS, AND DIETETIC INTERNSHIPS, IN SUPPORT OF TOMORROW'S CARE GIVERS.
