IN 2015, THE COCA-COLA SCHOLARS FOUNDATION ALSO CONTRIBUTED \$400,000 TO PHI THETA KAPPA AND \$50,000 TO THE AMERICAN ASSOCIATION OF COMMUNITY COLLEGES. THESE CONTRIBUTIONS WILL BE USED BY PHI THETA KAPPA AND AACC TO PROVIDE 350 SCHOLARSHIPS TO TWO-YEAR COLLEGE STUDENTS CURRENTLY ENROLLED IN A TWO-YEAR INSTITUTION OR MAKING THE TRANSITION FROM A TWO-YEAR COLLEGE TO A FOUR-YEAR UNIVERSITY.
