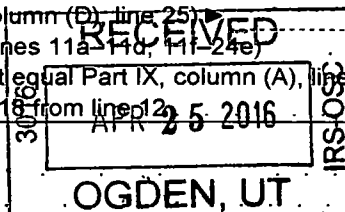

This summer during the Eight Week GraceWorks Alaska Campaign we hosted 926 volunteers from 66 church or school groups. In addition we had a volunteer staff of about 40 serving and leading these teams. We had teams from 22 states. We served about 17,500 meals to our volunteers and staff this summer. We worked in 11 public parks all summer -- 5 days a week -- every day. Anchorage, Eagle River, Palmer, and Wasilla. I figure we hosted about 88 community evangelistic park parties - complete with bounce house and food served. GraceWorks served 16,750 free meals to disadvantaged children in Anchorage parks this summer. These are mostly children who receive free meals at school due to family income, but in the summer they are hungry. Other projects included our Iditarod Mission in Fairbanks/ Anchorage and five Native village projects involving about 55 volunteers.

Overseas, We took a evangelism team of 17 people to Romania. Expenses included plane tickets, insurance, ground costs (food/housing/transportation). Also included here is 5% of Scott Kirby Salary package since he organized and led these teams. We also made gifts of \$4,125 total to Romanian church workers.
