We provide agencies with management training, technical information and connection to vital resources in efforts to support the sustainability and growth of the state's charitable community. The Center conducts more than 60 statewide workshops each year based on best practices and topics outlined in our guidebook, Principles &amp; Practices of Nonprofit Management. In addition to our training workshops, the Center partners with nonprofit, private and government agencies to present community forums, webinars and conferences, including Positioned for Progress, a joint annual conference that convenes Mississippi's social service sector. Since inception, the Center has trained more than 8,000 nonprofit professionals to more efficiently serve members of their communities through direct outreach and organizational management skills. The Center currently provides member services to more than 250 nonprofit organizations throughout the state, and the Center responds to more than 3,000 calls and emails each year to provide professional guidance and assistance for nonprofits across Mississippi.
