It is the mission of the Thompson Cancer Survival Center Foundation to provide consistent financial support to the Thompson Cancer Survival Center for specific objectives in scientific and clinical research, programs emphasizing prevention and early detection, educational services, and for the expansion and development of new programs which underscore Thompson Cancer Survival Center's commitment to facilitate accessible cancer care to all people throughout the region

Social Services Operating Grant. See Schedule O Social Services Operating Grant. Expenses \$431,115 including Grants of \$431,115. The Foundation made a grant to support the operations of the Social Services Department of the Thompson Cancer Survival Center. The Social Services Department receives referrals from Covenant Health facilities when patients are identified that could benefit from the services provided by this department. In 2015, the Social Services Department supported 1,632 new patient referrals and 4,153 follow-up patients. Additionally, there were 1,028 new patients referred for nutritional counseling and education and 3,535 follow-up patients were also supported. The Social Services department includes a Genetics Clinic staffed by two licensed and certified genetic counselors who provide breast cancer and hereditary cancer risk assessments and who coordinate genetic testing. In 2015, the Genetics Clinic received referrals from Covenant Health facilities for 431 new patients who were in need of counseling, including 331 who pursued genetic testing. Of those, 17% tested positive for a hereditary cancer syndrome. Whether patients tested positive or negative for a hereditary cancer syndrome, decided not to pursue testing, or were not appropriate candidates for testing, they and their families were able to make informed decisions regarding their medical management based on the genetic counseling they received.

Clinical Trials Operating Grant. See Schedule O Clinical Trials Operating Grant. Expenses \$266,762, including Grants of \$266,762. TCSC Foundation provides an operating grant to the Thompson Cancer Survival Center for its Clinical Trials program. Since the opening of TCSC in 1988, the Clinical Trials Department has enrolled 2,304 patients in clinical trials. The TCSC Clinical Trials Department currently has 11 active treatment patients who were referred from Covenant Health facilities and 273 patients in follow-up. In 2015, TCSC Clinical Trials Department enrolled 21 patients to oncology clinical trials. Increased efforts have been made to attend Methodist Medical Center, Blount, Sevier and Parkwest tumor board meetings. To help with screening efforts, Research Nurse Coordinators are assigned to specific physician schedules for screening and to specific locations for coverage, including Thompson Oncology Group's Oak Ridge, Sevierville, West Knoxville, and Blount sites. New studies increase referrals locally and regionally and give current patients the ability to be treated with state-of-the-art care in their own community. Involvement in prevention and treatment trials offers an improved means of health strategies for individuals at risk for certain cancers, as well as access to proven standard cancer treatments and new, developing cutting edge therapies for those diagnosed with cancer.

Multidisciplinary Operating Grant. See Schedule O Multidisciplinary Operating Grant. Expenses \$181,704, including Grants of \$181,704. Multidisciplinary Treatment facilitates specialty physicians discussing treatment options based on the individuality of one's circumstances. The Multidisciplinary Cancer Care Coordinator schedules a private consultation for each patient with the members of the specialty team. This approach affords the opportunity for the physician to relate one-on-one with the patient and explain treatment choices in lay language. Patients in need of this support come from various Covenant Health facilities. In 2015, 279 breast patients were under conference discussion and 108 were seen in clinic, 94 chest patients were under conference discussion and 21 were seen in clinic, and an additional 318 general tumor patients and 3 neuro cancer patients were discussed in conference.
