	Elam provided discipleship and Bible training to help Persian-speaking people serve in Christian ministry within the church. In 2015, we had discipleship conferences, advanced Bible courses, distance learning programs, and our three-month leadership course. We also continued to develop our women's ministry to bring healing where there has been abuse, promote a healthy view of women's value, and provide pastoral counseling. We continued to print and distribute Bibles and New Testaments in Persian. Action Bible New Testaments and entire Action Bibles for children were also printed in 2015. We published and printed Christian literature for discipleship, Bible study, evangelism, and discipleship. We also produced TV programs in Persian to advance Bible teaching and discipleship. This includes programming for women, children, Christian worship, and evangelism. These programs were broadcast on satellite TV and over the Internet. Lastly, we provided advocacy, financial support and pastoral care for persecuted Persian-speaking Christians and their families. We also have a growing outreach program to Persian-speaking refugees in Europe, primarily through partnering with churches to assist them in outreach and integration of refugees into local communities.
