For the year ended December 31, 2015, the Wylde Center operated the following programs (i)Youth Programming The Wylde Center is a resource for a diverse community and regards the education of youth on environmental sustainability as one of our main priorities Our youth environmental education program serves over 5,100 students in grades preK-12 throughout the metro Atlanta area including eight of the nine City Schools of Decatur, two Atlanta Public Schools, and one school in DeKalb County. The Wylde Centers experiential environmental program teaches students the importance of good nutrition to health and how the food choices we make have an impact on the environment and community In addition, the program teaches students about the environment through scientific and mathematical studies In 2015, the Wylde Center saw growth in all educational programs, facilitating over 16,000 formal experiential learning interactions during nearly 500 instructional hours through the following programs Field Trips Wylde Center environmental education field trips bring students to Wyldes four greenspaces to explore the science of the natural world Field trips engage students in first-hand discoveries about topics from agriculture to zoology and everything in between Classes are led by highly trained and enthusiastic environmental educators As students encounter Wyldes gardens, streams, and woodlands, they learn to think critically, creatively, and responsibly about the world around them In 2015, more than 1,000 students attended a Wylde field trip Farm to School Since 2012, The Wylde Center has been providing the Farm to School program to improve students and families awareness of the environment, nutrition, and gardening By providing on-site education and garden maintenance, Wylde delivers a high quantity and quality of garden-based education that engages students minds and bodies in a hands-on learning experience Teachers are able to choose from two dozen classes taught on site at their school by a highly trained Wylde educator Visits to the same partner schools occur several times over the course of the year In 2015, Wylde worked with 11 partner schools Teacher Trainings Wylde Center offers one-day training courses for educators opening up the eyes and minds of teachers and staff to see edible school gardens as a versatile, hands-on teaching tool and gives them the skills to use this green resource, too Teachers learn how to use gardens to interpret Language Arts or Math, Science or History, Agriculture or Art Garden Coaching Wylde offers Garden Coaching services for schools, churches, and other non-profit organizations to help start gardens and keep them going In 2015, Wylde worked with five schools through its Garden Coaching program (ii)Community Outreach and Events Community outreach and events enable the Wylde Center to serve diverse populations The Wylde Center offers programs to students, families, and seniors at the Decatur Housing Authority that mirror the successful Farm to School program Free environmental education classes are provided at DeKalb County libraries, and the Wylde Center hosts the Decatur Earth Day celebration, an annual plant sale, and several special events to raise awareness and funds (iii)Decatur Farm to School The Decatur Farm to School Initiative (DF2S) is a grassroots effort led by parents, teachers, school administrators, community members and organizations Farm to School programs connect schools with local farms with the objectives of serving healthy meals in school cafeterias, improving student nutrition, providing health and nutrition education opportunities that will last lifetime, and supporting local farmers The Decatur Farm to School Initiative officially became a program of the Wylde Center in October 2010 The Wylde Center and the DF2S share the same goals of supporting fresh produce in the cafeteria as well as training teachers, providing in classroom instruction and supporting school gardens (iv)Wylde Center Gardens More than 6,000 people visit the Wylde Centers four sites per year for recreation, event rentals, special events, volunteering, and education opportunities Edgewood Community Learning Garden The Wylde Centers latest garden as of August 2012, the Edgewood Community Learning Garden (ECLG) located in Atlanta is enjoyed both by the community and the local schools Located in the Edgewood neighborhood, the ECLG's land is owned by the Zeist Foundation but managed by the Wylde Center Whiteford Elementary and other area students garden, eat what they grow and learn about environmental stewardship at the ECLG The Wylde Center staff is working to manage the greenspace and provide dynamic programming Hawk Hollow Garden Donated to the Wylde Center in 2012, Hawk Hollow Garden is located in the Kirkwood neighborhood in Atlanta The site is still being developed and will feature large native plantings The site is used for field trips by the Wylde education staff for area schools Sugar Creek Garden In partnership with the City of Decatur, the Wylde Center has managed this parcel of land since 2010 The site is open to the community and is currently being used to grow produce, herbs, and native plants The Wylde Centers education staff uses this site for field trips Oakhurst Garden Started in 1997, the Oakhurst Garden is the flagship garden for the Wylde Center The site hosts the Wylde Center offices, community garden plots, education farm, greenhouse, event rental space, childrens play area, a chicken coop, and a native woodland garden, etc During the course of the year, more than 1,000 students visit the Oakhurst Garden for educator led field trips
