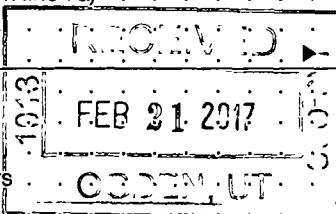

Amended return February 15, 2017: It has been discovered that there was an inadvertent typographical error on line 27 of Part II of Form 990EZ and that is corrected on this amended return. The original Form 990EZ shows the net asset amount as \$ 101,875 on line 27 of Part II rather than the correct amount of \$ 107,875. Please note that the three other lines that report the net asset value (Lines 21, 22, & 25 of Form 990EZ) all showed the correct \$107,875 net asset value. This correction is the only change from the original return made on this amended return.
