Goodwill advanced approximately \$459,000 to Career Academy, a charter school, which was sponsored by Goodwill and is related to the broader mission of Goodwill. The charter school owed Goodwill approximately \$56,000, as of December 31, 2015. Goodwill also paid Florida Goodwill Association (FGA), a membership association with a common officer, approximately \$10,000 for dues. In addition, during 2015 Goodwill paid Goodwill Industries International (GII), an affiliated national organization, approximately \$167,000 for annual dues. Goodwill also received payments from various related parties during 2015. Goodwill received approximately \$444,000 from the charter school which includes approximately \$41,000 from 2014 the expenses referenced above over the course of 2015.
