The Organization contracts with 23 providers to offer a wide range of services to clients. The Older Americans Act (OAA) is a federal program that provides assistance to older persons and caregivers and is the only federal supportive services program directed solely toward improving the lives of older people. This contract provided 9,412 unduplicated older persons and caregivers with services during 2015. The Alzheimer's Disease Initiative (ADI) program ensures that persons afflicted with Alzheimer's disease and other forms of dementia, are given essential services to help them age in place, in an elder-friendly environment, with security, dignity, and purpose. The program also provides support to family members and caregivers of persons afflicted with Alzheimer's disease.
