AS THE STATE DESIGNATED AREA AGENCY ON AGING FOR 7 COUNTIES IN NORTHEAST FLORIDA, WE ARE RESPONSIBLE FOR IDENTIFYING THE NEEDS OF ELDERS AND THEIR CAREGIVERS, DEVELOPING PLANS TO ADDRESS THOSE NEEDS, FUNDING SERVICES IN THE COMMUNITY AND PROVIDING OVERSIGHT AND STEWARDSHIP OF THE SERVICE SUBCONTRACTS TO MAKE SURE STANDARDS FOR HIGH QUALITY SERVICE ARE BEING MET AND THAT SERVICES ARE REACHING THOSE MOST IN NEED SOME OF THE SERVICES WE FUND INCLUDE, BUT ARE NOT LIMITED TO, CONGREGATE DINING AND HOME DELIVERED MEALS, SENIOR CENTER PROGRAMS AND ACTIVITIES, TRANSPORTATION, LEGAL ASSISTANCE, ADULT DAY CARE, COUNSELING, SUPPORT FOR CAREGIVERS INCLUDING RESpite, AND IN-HOME SERVICES INCLUDING HOMEMAKER AND PERSONAL CARE, AS WELL AS EVIDENCE BASED HEALTH AND WELLNESS AND DISEASE PREVENTION PROGRAMS AND CLASSES WE ALSO HAVE THE RESPONSIBILITY FOR ADVOCATING ON BEHALF OF ELDERS WITH ELECTED OFFICIALS AT ALL LEVELS, ENSURING THEY UNDERSTAND THE NEEDS OF ELDERS IN OUR COMMUNITY AS WELL AS THEIR CONTRIBUTIONS AFTER BEING DESIGNATED IN 2007 AS THE AGING RESOURCE CENTER, IN 2011 OUR ROLE WAS EXPANDED TO THE AGING AND DISABILITY RESOURCE CENTER (ADRC) AS AN ADRC WE SERVE AS THE FOCAL POINT FOR ELDERS, DISABLED ADULTS AND THEIR CAREGIVERS TO INFORMATION, REFERRAL AND ASSISTANCE WE HELP LINK INDIVIDUALS TO THE NECESSARY RESOURCES IN THE COMMUNITY THAT HELP THEM TO LIVE INDEPENDENTLY AND WITH DIGNITY TO ENHANCE THIS SERVICE, WE INCORPORATED A GRANT FROM THE NATIONAL COUNCIL ON AGING TO CREATE A BENEFITS ENROLLMENT CENTER WHERE WE SCREEN ELDERS AND ADULTS LIVING WITH DISABILITIES FOR ALL THE BENEFITS THEY MAY BE ELIGIBLE FOR AT ONE TIME AND THEN HELP THEM TO APPLY FOR THE BENEFITS FOR WHICH THEY APPEAR ELIGIBLE THIS WAY, THE INDIVIDUAL HAS JUST ONE PLACE TO CALL RATHER THAN SEVERAL, REDUCING THEIR FRUSTRATION AND ANXIETY AND EXPEDITING THE PROCESS FOR THEM TO RECEIVE THE NECESSARY ASSISTANCE TO FURTHER ASSIST ELDERS AND ADULTS LIVING WITH DISABILITIES, WE ALSO OFFER TRAVEL TRAINING WHERE A TRAINED STAFF PERSON HELPS THE INDIVIDUALS MAP A PUBLIC TRANSPORTATION ROUTE AND THEN ACCOMPANIES THEM ON THE ROUTE MULTIPLE TIMES UNTIL THEY ARE COMFORTABLE DOING IT THEMSELVES THIS SERVICES HAS HELP MANY ELDERS, INDIVIDUALS WITH DISABILITIES AND LOW INCOME INDIVIDUALS REMAIN ENGAGED IN THE COMMUNITY, REACH THEIR SITE FOR VOLUNTEERING, REACH THEIR JOB TRAINING SITES AND MORE, EMPOWERING THEM TO REMAIN INDEPENDENT WE CONTINUE TO WORK WITH THE VETERANS ADMINISTRATION TO PROVIDE THE VETERANS DIRECTED HOME AND COMMUNITY BASED SERVICES PROGRAM THIS GIVES VETERANS THE INDEPENDENCE THEY WANT AND NEED IN DETERMINING THEIR OWN CARE AND CARE-PROVIDER, ENABLING THEM THE LIVE MORE INDEPENDENTLY AND WITH DIGNITY AND THEIR HOMES AND THE COMMUNITY IN ADDITION, WE MANAGE SEVERAL UNIQUE PROGRAMS THAT HELP ELDERS THROUGHOUT OUR SEVEN COUNTIES WHEN FACING A FINANCIAL CRISIS THROUGH THE GENEROSITY OF DELORES BARR WEAVER AND THE COMMUNITY FOUNDATION, WE MANAGE THE SENIOR TO SENIOR PROGRAM IN BAKER, CLAY, DUVAL, NASSAU AND ST. JOHNS COUNTIES AND THROUGH THE GENEROSITY OF THE FRIENDS OF ELDERSOURCE WE STARTED EMERGENCY ASSISTANCE SERVING ELDERS (EASE) PROGRAM IN FLAGLER AND VOLUSIA COUNTIES BOTH OF THESE PROGRAMS ALLOW US TO HELP ELDERS IN A FINANCIAL CRISIS WHILE WORKING TO RESOLVE THE UNDERLYING CAUSE(S) OF THE CRISIS FUNDING FROM THE DUPONT FOUNDATION THROUGH THE COMMUNITY FOUNDATION (SAFETY NET) AND FROM THE EMERGENCY SERVICES AND HOMELESS COALITION THAT WE HAVE RECEIVED FOR THE PAST SEVERAL YEARS CONTINUE TO HELP US ENSURE NEEDY ELDERS DO NOT BECOME HOMELESS WE CONTINUE TO FOCUSE ATTENTION ON THE ISOLATION AND NEEDS OF LESBIAN, GAY, BISEXUAL AND TRANSGENDER (LGBT) ELDERS MORE ISOLATED AND ALONE THAN THE AVERAGE ELDER FOR FEAR OF HOW THEY MAY BE TREATED BY NON-LGBT ELDERS AND PROFESSIONALS PROVIDING SERVICES WE FORMED AN LGBT ELDERS TASK FORCE TOGETHER WE HAVE PROVIDED LGBT ELDER SENSITIVITY TRAINING TO OUR STAFF AND TO OUR SUBCONTRACTOR STAFF AND TO OTHERS IN THE COMMUNITY WE HAVE ALSO HELD COMMUNITY AWARENESS ACTIVITIES AND OUTREACH TO LGBT ELDERS SO THEY KNOW THEY CAN REACH US FOR HELP AND NOT FEEL THREATENED THIS PAST YEAR WE STARTED AN ELDER FRIENDLY BUSINESS CERTIFICATION PROGRAM THROUGH WHICH OLDER ADULT VOLUNTEERS EVALUATE A COMPANYS PHYSICAL SITE, WEBSITE AND CUSTOMER SERVICE, PROVIDING THEM WITH FEEDBACK ON STEPS THEY CAN TAKE TO BE ELDER FRIENDLY AND THEN CERTIFYING THEM WHEN THEYVE MET CERTAIN CRITERIA THIS PROGRAM ALLOWS OLDER ADULTS TO REMAIN COMFORTABLY ENGAGED IN THE MARKET PLACE WE VALUE THOSE WE SERVE EXCELLENT AND RESPONSIVE SERVICE HONESTY, INTEGRITY AND PROFESSIONAL BEHAVIOR RESULTS AND ACCOUNTABILITY PROACTIVE, INNOVATIVE AND VISIONARY EFFORTS COMMUNITY COLLABORATION THE KNOWLEDGE, LOYALTY, COMMITMENT AND UNSELFISH TEAM SPIRIT OF STAFF, VOLUNTEERS AND PROVIDERS AND OUR ROLE AS THE LEADER IN THE AGING NETWORK THESE VALUES ARE EVIDENT IN THE WORK WE DO BOTH AS AN AREA AGENCY ON AGING AND AS AN AGING AND DISABILITY RESOURCE CENTER
