HEP PROGRAMS CONTRIBUTE TO THE STABILIZATION OF THE CLIENT AND HELP THEM TO ACHIEVE SELF-SUFFICIENCY. HEP PROVIDES FREE DENTAL AND MEDICAL CARE, MENTAL HEALTH CARE, HEALTH AND WELLNESS COACHING THROUGH THE GO HEALTHY PROGRAM AND EMPLOYMENT ASSISTANCE AND COACHING THROUGH THE PATHWAYS TO EMPLOYMENT PROGRAM. HEP BELIEVES IN STRONG PARTNERSHIPS WITH OTHER AGENCIES ON A LOCAL AND NATIONAL SCALE. MEDICAL CARE - THIS PROGRAM IS PROVIDED ONSITE THROUGH A PARTNERSHIP WITH A MORTON PLANT OUTREACH TEAM. THE SERVICES INCLUDE MEDICAL ASSESSMENTS, LABORATORY SERVICES AND TREATMENTS FOR NONEMERGENCY ILLNESSES OR INJURIES OFFERED BY AN ON-SITE STAFF OF LICENSED PRACTICAL NURSES, NURSE PRACTITIONERS AND CASE MANAGERS. TRANSPORTATION - SERVICES INCLUDE TRANSPORTATION SERVICES OF TWO ROUNDTrips EACH WEEKDAY FOR VETERANS TO BAY PINES HOSPITAL. (CHAP) COMMUNITY HOUSING ASSISTANCE PROGRAM IS AVAILABLE TO ASSIST ELIGIBLE APPLICANTS AVOID POTENTIAL HOMELESSNESS BY ELIMINATING RENTAL PAYMENTS IN ARREARS, PROVIDING ONE-ON-ONE HOUSING COUNSELING TO ENSURE STABILITY OF THEIR NEW HOUSING SITUATION AND BY PROVIDING MOVE-IN COSTS IN INSTANCES OF HOMELESSNESS. THE PROGRAM PROVIDES ACADEMIC AND SOCIAL SKILL BUILDING ASSISTANCE FOR SCHOOL AGE YOUTH.
