Family Renew Community operates 3 facilities that provide transitional housing for homeless families. The Holly Hill facility has 14 one bedroom cottages to provide housing for families with children. The Daytona Beach facility is a 2 story apartment complex with 10 one bedroom and 1 two bedroom apartment. The Deland facility has 4 one bedroom and 3 two bedroom apartments. Our thrift store receives enough household donations to furnish all 32 apartments. Residents also receive complimentary referrals for clothing needs at the thrift store. During 2015 families received training, counseling, emergency medical and dental, and transportation for employment. Children were provided with daycare and after
