THE CLUBS ARE WELL LOCATED AND POSITIONED TO MAKE AN IMPACT ON THE KIDS, FAMILIES, AND COMMUNITIES WHOMOST NEED THEIR SERVICES AND PROGRAMS. THE CLUBS OPERATED FOR 10,641 HOURS DURING THE YEAR AND SERVED 1,699 YOUTH. AVERAGE DAILY ATTENDANCE AT ALL CLUBS WAS 529.
