The donations presented at the tea were raised earlier this year during the ACCCF biennial fundraiser, which included a car show, Shoppes at the Cove, Walk for Love, card party and brunch, tennis gala, golf tournament, concert, children's program, dog show and adoption clinic, and employee tag sale. This year's recipients were weighted in favor of social services and outreach programs serving veterans, the homeless,
