THE FOUNDATION HAS LOANED \$165,000 TO THE HEART OF SCOTTSDVILLE. THIS LOAN ALLOWED THE HEART OF SCOTTSDVILLE TO PURCHASE THE CARPENTER DENT BUILDING, A HISTORIC BUILDING ON THE SCOTTSDVILLE SQUARE. AFTER PURCHASING THE BUILDING, THE HEART OF SCOTTSDVILLE RENOVATED THE BUILDING AND THEN LEASED IT TO A RESTAURANT. THIS PROJECT WILL CONTINUE THE REVITALIZATION OF THE SCOTTSDVILLE SQUARE, AND BRING ADDITIONAL BUSINESS TO THE SQUARE AND THE CITY OF SCOTTSDVILLE.

REPORTS:

THE HEART OF SCOTTSDVILLE HAS PROVIDES PERIODIC UPDATES.THE RENOVATION WAS COMPLETED IN 2014. THE RESTAURANT SPACE WAS LEASED TO '1881 ON MAIN'. '1881 ON MAIN' WAS OFFICIALLY OPENED IN AUGUST 2014. IN AUGUST OF 2015 THE RESTURANT CLOSED.

THE HEART OF SCOTTSDVILLE HAS BEEN CURRENT WITH ALL INTEREST AND PRINCIPAL PAYMENTS ON THE LOAN. IN JUNE 2015 THE HEART OF SCOTTSDVILLE PAID A FULL YEARS DEBT SERVICE ON THE LOAN. IN DECEMBER 2015 THE HEART OF SCOTTSDVILLE PAID THE NOTE IN FULL. AS OF DECEMBER 31, 2015 THE OUTSTANDING BALANCE IS ZERO.

DIVERSIONS:
