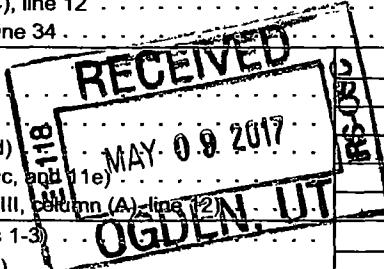

To create a Village where individuals with intellectual disabilities can live, learn, work, worship, and achieve their full potential. Day programs are currently offered in preparation for a residential community.

Reach High Educational and Pre-Vocational Day Program is for students with intellectual disabilities who are no longer in school, ages 18 and above. This is a year-round program conducted Mondays through Thursdays. The program includes reinforcing skills learned in school (such as reading and math) while incorporating social skills, art, physical fitness, and pre-vocational training. The students participate in regular field trips which allow them to have community-based instruction to generalize the skills they have learned in Reach High. The environment at High Point Village stresses teamwork and positive interactions with peers, teachers, volunteers, and guests.

4 b (Code ) (Expenses \$ 32,165. including grants of \$ 1,457.) (Revenue \$ 9,784.)

Afternoon Enrichment Classes are designed for individuals with intellectual disabilities ages eight and above. There is a spring semester and a fall semester with 50 students participating in one or more classes. Sixteen weekly classes are offered for recreation, life skills, arts and crafts, and academic enrichment. Recreational classes stress teamwork while improving coordination and health. Academic enrichment is provided through reading and community-based math while classes such as cooking and self-esteem build life skills. Fine arts classes enhance the individual as a whole and provide performance opportunities. The underlying purpose of this program is to provide a supportive peer group for these special individuals.

4 c (Code ) (Expenses \$ 16,675. including grants of \$ 1,425.) (Revenue \$ 2,230.)

Summer Camps for individuals with intellectual disabilities were conducted over four weeks in 2015. "Camp Grow" focused on children ages six through eleven. There was a limit of 12 participants to give individual attention. Our young "Villagers" kept busy with fun camp activities, crafts, and music with movement. "Camp Create" was conducted for 32 secondary students ages 12 and above. The focus of this camp was self-expression through fine art which also produced confidence. "Camp Explore" involved 40 secondary students and gave opportunities to explore science, nature, and the outdoors with water play, games, and presentations. "Art Camp" was conducted by a professional artist. All 4 weeks provide a genuine, positive, and memorable camp experience.
